THE CITY OF EDINBURGH COUNCIL (MEADOWS TO GEORGE STREET, EDINBURGH) (PROHIBITION OF MOTOR VEHICLES, ENTRY AND TURNING, ONE-WAY ROADS AND BUS PRIORITY MEASURES) (VARIATION NO. _) ORDER 202_ - TRO/21/32

The City of Edinburgh Council in exercise of their powers under sections 1(1), 2(1) to (3), 4(2), 32, 35, 45, 46, 49 and 53 of and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended, (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

- This Order may be cited as "The City of Edinburgh Council (Meadows to George Street, Edinburgh) (Prohibition of Motor Vehicles, Entry and Turning, One-Way Roads and Bus Priority Measures) (Variation No. _) Order 202_" and shall come into operation on the _____ day of _____ Two Thousand and _____.
- 2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (High Street, Edinburgh) (Prohibition of Motor Vehicles) Traffic Regulation Order 2001, shall have effect subject to the variations, insertions, substitutions, and additions thereto specified in Schedule 1 of this Order.
- 4. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Central Edinburgh) (Prohibition of Entry and Turning, One-Way Roads and Bus Lanes) Traffic Regulation Order 2004, shall have effect subject to the variations, insertions, substitutions, and additions thereto specified in Schedule 2 of this Order.
- 5. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Edinburgh Tram) (Prohibition of Entry, Motor Vehicles and Turning, One-Way Roads, Bus/Tram Priority Lanes and Weight Limit) Traffic Regulation Order 2010, shall have effect subject to the variations, insertions, substitutions, and additions thereto specified in Schedule 3 of this Order.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Edinburgh Corporation (Bristo Area – Various Street) (One-Way) Order 1963, shall have effect subject to the variations, insertions, substitutions, and additions thereto specified in Schedule 4 of this Order.
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The Lothian Regional Council (Victoria Street, West Bow and Candlemaker Row, Edinburgh) Traffic Regulation Order 1995,

shall have effect subject to the variations, insertions, substitutions, and additions thereto specified in Schedule 5 of this Order.

8. In this Order, except where the context otherwise requires, the follow expressions have the meanings hereby respectively assigned to them:

"the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018.

- 9. Designation of parking places and loading places and application of the 2018 Order thereto.
 - Each area on a road identified in a map tile as a parking place or loading place and, where applicable, by way of either a map tile label or the map schedule legend, or both, as an area marked out and signed for the use therein of specified classes of vehicles following the conditions specified in the 2018 Order in relation to that type of parking place or loading place, is designated as a parking place or, as the case may be, a loading place.
 - 2) Unless otherwise so identified, a parking place or a loading place shall be bounded on one side of its length by the edge of the carriageway and be an area marked either by a traffic sign or by another method of indicating the extent of a parking place or loading place as specified in the Traffic Signs Regulations and General Directions 2016.
 - 3) The provisions of the 2018 Order (other than Articles 3-1 and 7-1) shall apply to an area designated as a parking place by this Order as if in those provisions any reference to:
 - a) a parking place included a reference to an area designated as a parking place by this Order, and
 - b) a loading place included a reference to an area designated as a loading place by this Order.
- 10. Loading prohibition and/or waiting restrictions applicable in prohibited or restricted roads.

Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the 2018 Order shall have effect as though any loading prohibition and/or waiting restriction identified in a map tile and, where applicable, by way of either a map tile label or the map schedule legend, or both, and marked out and signed as a loading prohibition and/or waiting restricted road referred to in the 2018 Order.

11. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018, shall have the effect as if, in Schedule 2 to that Order: -

In <u>ARTICLE 2</u>

In ARTICLE 5

(2) Item 4 as set out in the Schedule hereto; where motor vehicles are entering the said road between 09:30 hours and 12:30 hours Monday to Sunday for the purposes of delivering or collecting goods or merchandise or while loading or unloading the vehicle at premises situated on the said road, provided that no vehicle shall by virtue of this article be left other than in a loading place during the permitted hours."
