THE CITY OF EDINBURGH COUNCIL (CASTLE CONCERTS) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/120

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (b) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Castle Concerts) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. (a) In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;

"authorised vehicle" means any vehicle authorised by the City of Edinburgh Council as being connected with the event that can, upon request, provide a valid accredited pass associated with the Castle Concerts events for the duration of this Order;

"emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;

"motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;

"pass" means an official pass issued by the City of Edinburgh Council's representatives for the purpose of this Order;

"resident" means someone who, for the purposes of this Order, is currently residing in Mound Place or St Giles' Street;

"road" has the same meaning as in Section 151 of the 1984 Act and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;

"Schedule" means a Schedule to this Order;

"the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.

(b) References in this Order to a disabled person, to a disabled person's badge, to a disabled person's vehicle and to a vehicle displaying a disabled person's badge in the relevant position shall be construed in accordance with the 1984 Act, The Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 and The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002.

- 3. Save as provided in Article 4, to facilitate the holding of concerts at Edinburgh Castle (as signed as affected by the events), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on the sections of roads described in Schedule 1 hereto, where prohibitions will apply to the roads in their entirety unless otherwise stated;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait on the section of road described in Schedule 2 hereto; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads described in Schedule 3 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.

- 4. Nothing in:
 - (a) Article 3 of this Order shall apply to emergency service vehicles;
 - (b) Article 3(a) of this this Order shall apply to authorised vehicle on the sections of roads
 - (c) Article 3(c) of this Order shall apply to *authorised vehicles* on the specific sections on **Johnston Terrace** and **St Giles' Street** described in Schedule 3;
 - (d) Article 3(c) of this Order shall apply to *resident permit parking bays* on the sections of **Mound Place** and **St Giles' Street** described in Schedule 3; and
 - (e) Article 3(c) of this Order shall apply to *enterprise car club bays* on the sections of **St Giles' Street** described in Schedule 3.
- 5. Nothing in Article 3(b) shall apply:
 - a. to motor vehicles being driven or used by disabled persons and which conspicuously display, so as to be clearly visible from the front of the vehicle, a valid disabled person's badge; and
 - b. so as to prevent any person from causing or permitting a vehicle to wait while the vehicle is in actual use for the purpose of delivering or collecting goods or while loading or unloading the vehicle at premises adjoining the said road; provided that:
 - (i) no such vehicle so engaged shall wait for a period of more than thirty minutes in the same place; and
 - (ii) no such vehicle so engaged shall return to the same place, unless a period of more than thirty minutes has elapsed since the termination of the previous waiting period.
- 6. "The City of Edinburgh Council (Castlehill) (Temporary Road Restriction and Traffic Regulation) Order 2024" will be suspended on the affected section of road during the hours and on the dates specified in the Schedules to this Order, to facilitate the holding of the Castle Concert events.
- 7. The 2018 Order will be suspended on the affected sections of roads specified in Schedules 2 and 3, during the hours and on the dates specified in the said Schedules.
- 8. The alternative route for through vehicular traffic will be by way of Castle Terrace, Lady Lawson Street, Lauriston Place, Forrest Road, Bristo Place, Teviot Place and George IV Bridge.

SCHEDULE 1 PROHIBITION OF VEHICLES

(A) from 09:01 hours on 28/06/2024 to 06:59 hours on 29/06/2024; from 10:31 hours on 29/06/2024 to 09:29 hours on 03/07/2024; and from 13:01 hours on 03/07/2024 to 01:00 hours on 17/07/2024 on:

Castlehill;

(B) from 07:00 hours on 28/06/2024 to 09:29 hours on 03/07/2024; and from 13:01 hours on 03/07/2024 to 01:00 hours on 17/07/2024 on:

(i) Ramsay Lane; (ii) Ramsay Garden; and (iii) Mound Place; and

(C) from 16:00 hours to 23:59 hours on 05/07/2024, 09/07/2024, 10/07/2024, 11/07/2024, 12/07/2024, 13/07/2024 and 14/07/2024 on:

(i) Johnston Terrace; (ii) Lawnmarket, between its junction with Castlehill and its junction with George IV Bridge; (iii) Castle Wynd North Steps; and (iv) Upper Bow.

SCHEDULE 2 RESTRICTION OF WAITING

From 16:00 hours to 23:59 hours on 05/07/2024, 09/07/2024, 10/07/2024, 11/07/2024, 12/07/2024, 13/07/2024 and *14/07/2024* on:

St Giles' Street, disabled person's parking bays on east side of north-south leg only.

SCHEDULE 3

PROHIBITION OF WAITING, LOADING & UNLOADING

(A) from 07:00 hours on 28/06/2024 to 06:59 hours on 03/07/2024; and from 13:01 hours on 03/07/2024 to 07:00 hours on 17/07/2024 on:

Johnston Terrace, *south side*: (1) from a point 33 metres or thereby south-west of the extended western kerbline of West Bow, south-westwards for a distance of 53 metres or thereby (*except authorised vehicles*); and (2) from a point 184 metres or thereby south-west of the extended western kerbline of West Bow, south-westwards for a distance of 125 metres or thereby (*except authorised vehicles*); we study a point 184 metres of 125 metres or thereby (*except authorised vehicles*);

(B) from 15:00 hours to 23:59 hours on 05/07/2024, 09/07/2024, 10/07/2024, 11/07/2024, 12/07/2024, 13/07/2024 and 14/07/2024 on:

Johnston Terrace, *north side*, from a point 27 metres or thereby south-west of its junction with Lawnmarket, south-westwards for a distance of 48 metres or thereby;

(C) from 07:00 hours on 28/06/2024 to 06:59 hours on 03/07/2024; and from 13:01 hours on 03/07/2024 to 07:00 hours on 17/07/2024 on:

Johnston Terrace, *north side*, from a point 236 metres or thereby north-east of the extended northern kerbline of Castle Terrace, north-eastwards for a distance of 80 metres or thereby (*except authorised vehicles*); and

(D) from 16:00 hours to 23:59 hours on 05/07/2024, 09/07/2024, 10/07/2024, 11/07/2024, 12/07/2024, 13/07/2024 and 14/07/2024 on:

(i) **Castlehill**; (ii) **Ramsay Lane**; (iii) **Ramsay Garden**; (iv) **Mound Place** (*except resident permit parking bays*); (v) **Lawnmarket**, *both sides*, between its junction with Castlehill and its junction with George IV Bridge; (vi) **Upper Bow**; and (vii) **St Giles' Street**: (1) **east-west leg**, *both sides* in its entirety; and (2) **north-south leg**: (a) *west side* in its entirety; and (b) *east side*: (i) from the northern kerbline of St Giles' Street, southwards to the north extremity of the disabled person's parking bays; and (ii) from the south extremity of the disabled person's parking bays, southwards to its junction with High Street/Lawnmarket (*except resident permit parking bays, Enterprise Car Club bays and authorised vehicles*).
