THE CITY OF EDINBURGH COUNCIL (SCHOOL STREETS, EDINBURGH) (PROHIBITION OF MOTOR VEHICLES) (VARIATION NO 1) ORDER 2022 - TRO/19/87


The City of Edinburgh Council in exercise of their powers under Sections 1(1), 2(1) to 2(3), 4(2), 32, 35, 45, 46, 49 and 53 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended (which Act as so amended is hereinafter referred to as "the 1984 Act"), and of all other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:

1. This Order may be cited as "The City of Edinburgh Council (Schools Streets, Edinburgh) (Prohibition of Motor Vehicles) (Variation No 1) Order 2022" and shall come into operation on the Sixth day of June Two thousand and twenty-two.
2. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, The City of Edinburgh Council (Schools Streets, Edinburgh) (Prohibition of Motor Vehicles) Traffic Regulation Order 2017 shall have effect subject to the amendments specified in the Schedule to this Order.
