THE CITY OF EDINBURGH COUNCIL (CRAIGENTINNY ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2024 – TEMP/24/119

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Craigentinny Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2024". The order shall have effect on the Fifteenth day of July Two thousand and twenty-four up to and including the Thirtieth day of August Two thousand and twenty-four.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2018 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2018; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate carriageway strengthening and resurfacing works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on: (i) **Britwell Crescent**, at its junction with Craigentinny Road; (ii) **Loaning Road**, at its junction with Craigentinny Road; (iii) **Loganlea Road**, at its junction with Craigentinny Road; and (iv) **Restalrig Drive**, at its junction with Craigentinny Road, provided that no more than one of the measures described in these sections shall be enacted at any time; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) **Britwell Crescent**, from its junction with Craigentinny Road, south-westwards for a distance of 50 metres or thereby; (ii) **Craigentinny Road**, between its junction with Sleigh Drive and its junction with Craigentinny Avenue; (iii) **Loaning Road**, from its junction with Craigentinny Road, south-westwards for a distance of 50 metres or thereby; (iv) **Loganlea Drive**, from its junction with Craigentinny Road, south-westwards for a distance of 50 metres or thereby; (v) **Loganlea Road**, from its junction with Craigentinny Road, south-westwards for a distance of 50 metres or thereby; and (vi) **Restalrig Drive**, from its junction with Craigentinny Road, south-westwards for a distance of 50 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2018 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative routes for through vehicular traffic will be by way of: (i) Britwell Crescent – Britwell Crescent, Restalrig Avenue, Craigentinny Avenue and Craigentinny Road; (ii) Loaning Road – Loaning Road, Loaning Crescent, Restalrig Drive and Craigentinny Road; (iii) Loganlea Road – Loganlea Road, Loganlea Terrace, Loganlea Avenue, Loganlea Drive and Craigentinny Road; and (iv) Restalrig Drive – Restalrig Drive, Loaning Crescent, Loaning Road and Craigentinny Road.
