THE CITY OF EDINBURGH COUNCIL (GLASGOW ROAD (A8) AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/51

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Glasgow Road (A8) Area) (Temporary Road Restriction and Traffic Regulation) Order 2025". The order shall have effect on the Twenty-eighth day of April Two thousand and twenty-five and shall remain in force up to and including the Thirtieth day of May Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate investigative surveys relating to drainage and geotechnical works (as signed as affected by the works), no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on *both sides* of: (i) **Glasgow Road (A8) eastbound carriageway**, from its junction with Newbridge Roundabout, eastwards to Gogar Underpass *Monday to Thursday* (09:30 hours to 15:30 hours each day); (ii) **Glasgow Road (A8) westbound carriageway**: (1) from Gogar Underpass, westwards to its junction with Station Road *Monday to Thursday* (09:30 hours to 15:30 hours each day); and (2) between its junction with Station Road and its junction with Newbridge Roundabout *Monday to Friday* (19:30 hours to 06:30 hours each day); (iii) **Ingliston Interchange eastbound on-slip towards A8** in its entirety *Monday to Thursday* (09:30 hours to 15:30 hours each day), and (iv) **Newbridge Roundabout (north section only)**, between A89 and Glasgow Road (A8) *Monday to Thursday* (09:30 hours to 15:30 hours each day).
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.
