THE CITY OF EDINBURGH COUNCIL (BURDOCK ROAD, SOUTH QUEENSFERRY) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/54

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- This Order may be cited as "The City of Edinburgh Council (Burdock Road, South Queensferry) (Temporary Road Restriction and Traffic Regulation) Order 2025". The order shall have effect on the Twenty-eighth day of April Two thousand and twenty-five and shall remain in force up to and including the Nineteenth day of May Two thousand and twentyfive.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate raised table installation works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on **Burdock Road**: (i) at its junction with Station Road; (ii) at a point 192 metres or thereby south of its junction with Station Road; (iii) at the extended southern kerbline of Craw's Close; and (iv) at the extended northern kerbline of Craw's Close, provided that no more than one of measures described in this section be enacted at any time; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of **Burdock Road**: (i) from its junction with Station Road, southwards for a distance of 20 metres or thereby; and (ii) from the projected north gable end of No. 26 Station View, southwards to its junction with Craw's Close.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative route for through vehicular traffic will be by way of Station Road, The Loan, Kirkliston Road, Scotstoun Avenue, Borrowman's Square, Packard Street, Hewlett Way, Daybell Loan and Carlow Gardens.
