THE CITY OF EDINBURGH COUNCIL (JOHN STREET & PITTVILLE STREET AREA, PORTOBELLO) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/30

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (John Street & Pittville Street Area, Portobello) (Temporary Road Restriction and Traffic Regulation) Order 2025". The order shall have effect on the ninth day of June Two thousand and twenty-five and shall remain in force up to and including the thirteenth day of July Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate footway and raised table construction works (as signed as affected by the works), no person shall:
 - (a) drive or cause or permit to be driven any vehicle on: (i) **John Street**, at its junction with Abercorn Terrace; and (ii) **Pittville Street**, at its junction with Abercorn Terrace, provided that no more than one of the measures described in this section be enacted at any time.
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of **Abercorn Terrace**, from a point 22.5 metres or thereby north-west of the extended north-west kerbline of Pittville Street, south-eastwards for a distance of 165 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative routes for through vehicular traffic will be by way of: (i) **John Street** Abercorn Terrace, Pittville Street and Elcho Terrace; and (ii) **Pittville Street** Abercorn Terrace, John Street and Elcho Terrace.
