THE CITY OF EDINBURGH COUNCIL (QUEENSFERRY ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/64

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Queensferry Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025" and shall have effect on the ninth day of June Two thousand and twenty-five and shall remain in force up to and including the fifteenth day of August Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "bus lane" has the same meaning as in Section 44(4) of the Transport (Scotland) Act 2001; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
- 3. Save as provided in Article 4 of this Order, to facilitate a safe working area for footway renewal works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit any vehicle to be driven on *both sides* of: (i) **Columba Road**, at its junction with Queensferry Road; and (ii) **Gardiner Road**, at its junction with Queensferry Road; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) **Queensferry Road**, from the south-east kerbline of Forthview Terrace, south-eastwards to the north-west kerbline of Seaforth Drive; (ii) **Columba Road**, from its junction with Queensferry Road, south-eastwards for a distance of 50 metres or thereby; and (iii) **Gardiner Road**, from its junction with Queensferry Road, south-eastwards for a distance of 50 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. 'The City of Edinburgh Council (Queensferry Road/Hillhouse Road and Telford Road, Edinburgh) (Bus Priority Lane) and (Various Streets, Edinburgh) (Prohibition of Waiting) (Variation) Traffic Regulation Order 2001' will be suspended in relation to the bus lane on the south-west side of Queensferry Road in so far as it is affected by the restrictions specified in Article 3 of this Order.

7. The alternative routes for through vehicular traffic with respect to the closures will be by way of: (i) **Columba Road** – Columba Road, Columba Avenue and Queensferry Road; and (ii) **Gardiner Road** – Gardiner Road, Jeffrey Avenue, Columba Road, Columba Avenue and Queensferry Road.
