THE CITY OF EDINBURGH COUNCIL (CORSTORPHINE ROAD & ORMIDALE TERRACE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/67

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Corstorphine Rd & Ormidale Terrace) (Temporary Road Restriction and Traffic Regulation) Order 2025". The order shall have effect on the Eighth day of June Two thousand and twenty-five and shall remain in force up to and including the Nineteenth day of December Two thousand and twenty-five.
- In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes; "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate a safe working area for sewer installation works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of **Ormidale Terrace** from the extended north kerbline of Corstorphine Road to the extended south kerbline of Abinger Gardens and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of (i) **Corstorphine Road** from the extended east building line of 10 Corstorphine Road eastwards to the extended east building line of 13 Corstorphine Road and (ii) **Ormidale Terrace** from the extended north kerbline of Corstorphine Road northwards to the extended north building line of 1B Ormidale Terrace.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The City of Edinburgh Council (Greenways) Order 1997 shall be suspended in relation to red line stopping and waiting restrictions and Greenway loading bays on the affected sections of Corstorphine Road and Ormidale Terrace described in Article 3 (b) of this Order, to facilitate the works.
- 6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

7. The alternative route for through vehicular traffic will be by way of Corstorphine Road, Murrayfield Road, Kingsburgh Road, Murrayfield Gardens and Abinger Gardens.
