THE CITY OF EDINBURGH COUNCIL (ROYAL HIGHLAND SHOW) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/72

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 62 of the Roads (Scotland) Act 1984, as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- This Order may be cited as "The City of Edinburgh Council (Royal Highland Show) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect during the hours and on the dates specified in Article 11(ii)(2) and (iii) and Schedules 1 to 7 of this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;

"Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;

"event related vehicle" means any vehicle authorised by City of Edinburgh Council as being connected with the event who has been issued with a permit;

"local buses" means a public service vehicle used for the provision of a local service provided for the sole purpose of transporting people to/from the Royal Highland Show and not being an excursion or tour;

"local bus 97, 98 & N98" means a public service vehicle used for the provision of the said local service numbers, provided for the sole purpose of transporting people to/from the Royal Highland Show and not being an excursion or tour;

"motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;

"public service vehicle" has the same meaning as in Section 1 of the Public Passenger

Vehicles Act 1981, and, for the purposes of this Order, applies where the said vehicle or vehicles are being operated as a Local Service, as defined in the said Act;

"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road; "Schedule" means a Schedule to this Order;

"the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025;

"tram" shall have the same meaning assigned to that phrase by Section 82 of the Edinburgh Tram (Line One) Act 2006; and

"vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.

- 3. The restrictions specified in Articles 4 to 10 of this Order are to facilitate the free flow of traffic during the Royal Highland Show (as signed as affected by the event).
- 4. Save as provided in Article 11(i), no person shall, drive or cause or permit to be driven any vehicle on the section of road specified in Schedule 1.

- 5. Save as provided in Articles 11(i) and (ii)(1), no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any motor vehicle to enter into, remain, or proceed in or on any part of any length of road specified in Schedule 2.
- 6. Save as provided in Articles 11(i), (ii)(2) and (iii), no person shall, except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the length of road described in Schedule 3, otherwise that in the direction specified in the said Schedule.
- 7. Save as provided in Articles 11(i) and 12 no person shall, except with the permission of a Parking Attendant, cause or permit any vehicle to wait, or load onto or unload from any vehicle on the sections of roads specified in Schedule 4.
- 8. Save as provided in Article 11(i), no person shall, except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the road specified in column 1 of Schedule 5, so as to make the prohibited turn specified in column 2, into the road specified in column 3 of the said Schedule.
- 9. Save as provided in Article 11(i), no person shall, except upon the direction or with the permission of a police constable in uniform, drive any motor vehicle on the road specified in column 1 of Schedule 6 at a speed exceeding that specified in column 2 of the said Schedule.
- 10. Save as provided in Article 11(i), no person shall, except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the road specified in column 1 of Schedule 7, so as to make the prohibited turn specified in column 2, into the road specified in column 3 of the said Schedule.
- 11. Nothing in:
 - (i) Articles 4 to 10 shall apply to emergency service vehicles;
 - (ii) Articles 5 and 6 shall apply to *event related vehicles* on the sections of:(1) Fairview Road specified in Schedule 2:

(2) **Fairview Road**, **Almond Drive** specified in Schedule 3 (C) and **Hallyards Road** (from 07:00 hours on 19/06/2025 to 23:59 hours on 22/06/2025) specified in Schedule 3 (F).

- (iii) Article 6 shall apply to *local buses* numbered 97, 98, N98 and *Tram* shuttle buses on the section of **Ingliston Road** (from 23:59 hours on 18/06/2025 to 23:59 hours on 22/06/25) specified in Schedule 3 (B).
- 12. Nothing in Article 7 shall prevent any person from causing or permitting a *local bus* to wait on the sections of road described, to enable a person to board or alight, provided that the local bus shall so wait, for no longer than the period of time outlined:

(i) **Fairview Road** (south side) from its junction with Almond Drive to its junction with Eastfield Road, as specified in Schedule 4 (A), in relation to *local bus* number N98 for no more than 10 minutes; and

(ii) **George Street** as specified in Schedule 4 (B), in relation to *local buses* numbered 98 and N98 for no more than 15 minutes.

- 13. The alternative routes for through vehicular traffic with respect to: (i) road closure; (ii) prohibition of motor vehicles; (iii) one-way restrictions; and (iv) prohibition of turning (left/right/u-turn), will by way of: B800 (*from Lochend Road to the A89*), A89 (*from the B800 to Newbridge Roundabout*), Newbridge Roundabout, Glasgow Road (*from Newbridge Roundabout to Gogar Roundabout*), Gogar Roundabout, Eastfield Road, Fairview Road and Lochend Road (*from Glasgow Road to Hallyards Road*).
- 14. 'The 2025 Order shall be suspended in so far as it is affected by the waiting restrictions/loading prohibitions specified in Schedule 4 of this Order.
- 15. The Lothian Regional Council (A8 Glasgow Road, Edinburgh) (Central Reserve Gaps) (Prohibition of Turning) Traffic Regulation Order 1996. shall be suspended in so far as it is affected by the restrictions specified in Article 8 and described in Schedule 5 of this Order.
- 16. The existing national speed limit of 60 miles per hour shall be suspended in so far as it is affected by the restrictions specified in Article 9 and described in Schedule 6(A) of this Order.
- 17. The City of Edinburgh Council (Eastfield Road, Edinburgh) (40 mph Speed Limit) Order 2009' shall be suspended in so far as it is affected by the restrictions specified in Article 9 and described in Schedule 6(B) of this Order.
- 18. The A8 Trunk Road (Gogarstone-Newbridge) (Prohibition of Specified Turns) Order 1996 shall be suspended in so far as it is affected by the restrictions specified in Article 10 and described in Schedule 7 of this Order.

SCHEDULE 1 ROAD CLOSURE

(A) From 23:59 hours on 18/06/2025, 19/06/2025, 20/06/2025 and 21/06/2025 to 02:30 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 respectively on:

Ingliston Road, from its junction with Glasgow Road (A8) to its junction with Fairview Road.

(B) From 07:00 hours to 21:00 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 respectively on:

Eastfield Road, from the extended south-west kerbline of the eastbound on-slip road to Glasgow Road (A8), southwards to the extended north-west kerbline of the westbound off-slip road from Glasgow Road (A8).

SCHEDULE 2 PROHIBITION OF MOTOR VEHICLES

From 21:00 hours on 18/06/2025, 19/06/2025, 20/06/2025 and 21/06/2025 to 02:30 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 respectively on: **Fairview Road**, from its junction with Ingliston Road to its junction with Almond Drive.

SCHEDULE 3 ONE-WAY ROADS

(A) *from 07:00 hours on 14/06/25 to 23:59 hours on 18/06/2025* on: **Ingliston Road**, from the south kerbline of the access road to Little Flyers Nursery to its junction with Glasgow Road (A8), otherwise than in a *southbound* direction.

(B) from 23:59 hours on 18/06/2025 to 23:59 hours on 22/06/2025 and from 23:59 hours on 22/06/2025 to 17:00 hours on 23/06/2025 respectively on:

Ingliston Road, from the south extent of the entrance to the BCA Car Park to its junction with Glasgow Road (A8), otherwise than in a *southbound* direction.

(C) from 21:00 hours on 18/06/2025, 19/06/2025, 20/06/2025 and 21/06/2025 to 02:30 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 respectively on:

(i) **Fairview Road**, from its junction with Almond Drive to its junction with Eastfield Road, otherwise than in an *eastbound* direction; and (ii) **Almond Drive**, from its junction with Almond Avenue to its junction with Fairview Road, otherwise than in a *southbound* direction.

(D) *from 00:01 hours to 12:59 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025* on: **Lochend Road**, from its junction with Newliston Road (B800) to its junction with Hallyards Road, otherwise than in a *southbound* direction.

(E) from 13:00 hours to 23:59 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 on: **Lochend Road**, from its junction with Hallyards Road to its junction with Newliston Road (B800), otherwise than in a *northbound* direction.

(F) from 07:00 hours on 19/06/2025 to 23:59 hours on 22/06/2025 and from 23:59 hours on 22/06/2025 to 17:00 hours on 25/06/2025 respectively on:

Hallyards Road, from the most south extent of the entrance to Ingliston Showground (West Gate 13) to its junction with Glasgow Road (A8), otherwise than in a *southbound* direction.

SCHEDULE 4 PROHIBITION OF WAITING, LOADING AND UNLOADING

(A) from 19:00 hours on 18/06/2025, 19/06/2025, 20/06/2025 and 21/06/2025 to 03:30 hours on 19/06/2025, 20/06/2025, 21/06/2025 and 22/06/2025 respectively on:

(i) **Almond Drive**, *both sides*, from its junction with Fairview Road to its junction with Almond Avenue; and (ii) **Fairview Road**, *both sides*, in its entirety.

(B) from 06:00 hours on 19/06/2025 to 23:59 hours on 22/06/2025 on:

George Street, *north side*, (i) from the west kerbline of Hanover Street westwards for a distance of 107 metres or thereby, (ii) from a point 123.5 metres west of the west kerbline of Hanover Street westwards for a distance of 65 metres or thereby and *south side* from its junction with Hanover Street to its junction with Frederick Street.

(C) from 07:00 hours on 19/06/2025 to 23:59 hours on 22/06/2025 on:

Hallyards Road, *both sides*, from its junction with Glasgow Road (A8) to the most north extent of the entrance to the Ingliston Showground (West Gate 13).

(D) from 07:00 hours to 16:29 hours on 19/06/2025; from 02:31 hours to 16:29 hours on 20/06/2025; from 02:31 hours to 16:29 hours on 21/06/2025; and from 02:31 hours to 23:59 hours on 22/06/2025 respectively on:

Glasgow Road (*A8*): *north side*, from a point 305 metres east of the extended east building line of 123 Glasgow Road eastwards for a distance of 57 metres or thereby; and *south side* from the extended east kerbline of Lilybank Road eastwards for a distance of 67 metres or thereby.

(E) from 16:30 hours on 19/06/2025, 20/06/2025 and 21/06/2025 to 02:30 hours on 20/06/2025, 21/06/2025 and 22/06/2025 respectively on:

Glasgow Road (*A8*) *north side*, from its junction with Newbridge Roundabout, eastwards to its junction with Eastfield Road (eastbound off slip road), *excluding:(i) from a point 6 metres or thereby east of the extended east kerbline of Lochend Road eastwards for a distance of 34 metres or thereby; (ii) from a point 25 metres or thereby east of the extended east kerbline of Station Road eastwards for a distance of 43 metres or thereby; (iii) from a point 190 metres or thereby east of the extended east building line of 171 Glasgow Road eastwards for a distance of 60 metres or thereby; (iv) from a point 678 metres or thereby east of the extended east building line of 171 Glasgow Road eastwards for a distance of 55 metres or thereby; and <i>south side*, from its junction with Eastfield Road (westbound on-slip road), westwards to its junction with Newbridge Roundabout excluding: (i) from a point 47 metres or thereby west of the extended west kerbline of Norton Mains Cottages westwards for a distance of 55 metres or thereby; (ii) from a point 417 metres or thereby west of the extended west kerbline of S55 metres or thereby; (iii) from a point 417 metres or thereby west of the extended west kerbline of 55 metres or thereby; (iii) from a point 417 metres or thereby west of the extended west kerbline of 86 Glasgow Road westwards for a distance of 25 metres or thereby; and (iv) from a point 238 metres or thereby west of the extended west building line of 56 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and is a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby; and (iv) for a distance of 25 metres or thereby.
