THE CITY OF EDINBURGH COUNCIL (HOLYROOD WEEK & GARDEN PARTY EVENTS) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/82

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers being satisfied that traffic on the lengths of roads specified in the Schedules hereto should be prohibited or restricted to facilitate the holding of the Holyrood Week & Garden Party Events and to enable members of the public to attend these events and being satisfied that it is not reasonably practicable for the event to be held otherwise than on a road and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, with the consent of the Scottish Ministers under section 16B(1)(b) and 16B(6)(b) of the said Act, hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Holyrood Week & Garden Party Events) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect during the hours and on the dates specified in the Schedules to this Order.
- 2. In this Order
 - (a) the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;

"event vehicles" means any vehicle authorised by City of Edinburgh Council as being connected with the event and displaying the appropriate permit;

"Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;

"goods" means merchandise, produce and corporeal moveable items of a similar nature (excluding money) and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025;

"road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;

- (b) References in this Order to a disabled person, to a disabled person's badge, to a disabled person's vehicle and to a vehicle displaying a disabled person's badge in the relevant position shall be construed in accordance with the 1984 Act, The Disabled Persons (Badges for Motor Vehicles) (Scotland) Regulations 2000 and The Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002.
- 3. Save as provided in Article 4 of this Order, to facilitate the holding of the Holyrood Week & Garden Party Events (as signed as affected by the event), no person shall:-
 - (a) except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to enter into, remain, proceed in or on any part of any length of road described in Schedule 1 hereto, where prohibitions apply to roads in their entirety unless otherwise stated;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait at any time from any vehicle on any part of any length of road described in Schedule 2; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of roads specified in Schedule 3

hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated.

- 4. Nothing in:-
 - (a) Article 3 shall apply to emergency service vehicles;
 - (b) Article 3(a) shall apply to event vehicles;
 - (c) Article 3(b) shall apply;
 - (i) so as to prevent any person from causing or permitting event vehicles to wait in any road described in Schedule 2 while the vehicle is in actual use for the purpose of delivering or collecting goods or while loading or unloading goods from or to premises adjoining the said road; provided that:
 - (1) no such vehicle so engaged shall wait for a period of more than thirty minutes in the same place; and
 - (2) no such vehicle so engaged shall return to the same place, unless a period of more than thirty minutes has elapsed since the termination of the previous waiting period.
 - (ii) to a vehicle displaying a valid disabled person's badge, provided that said vehicle is being used by, or for the conveyance of, the holder of a valid disabled person's badge.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Articles 3(b) and 3(c) of this Order.
- 6. The alternative route for through vehicular traffic with respect to the prohibition of vehicles will be by way of Abbeyhill, Abbey Mount, Easter Road, London Road, Leith Walk, York Place, Queen Street, Saint Colme Street, Ainslie Place, Great Stuart Street, Randolph Crescent, Drumsheugh Place, Drumsheugh Gardens, Chester Street, Palmerston Place, Torphichen Street, Dewar Place, Morrison Street, Lothian Road, Earl Grey Street, Brougham Street, Brougham Place, Melville Drive, Summerhall Crescent, Sciennes, Sciennes House Place, Causewayside, West Preston Street, East Preston Street, Dalkeith Road, Blackett Avenue, Minto Street, Mayfield Gardens, Craigmillar Park, Liberton Road, Gilmerton Road, Kingston Avenue, Old Dalkeith Road, Craigmillar Castle Road, Duddingston Road West and Willowbrae Road.

SCHEDULE 1 PROHIBITION OF VEHICLES

From 07:00 hours on 25/06/2025 to 16:00 hours on 04/07/2025 on: (i) **Abbey Strand**; (ii) **Horse Wynd**; and (iii) **North Approach**.

SCHEDULE 2 RESTRICTION OF WAITING

(A) <u>From 07:00 hours on 24/06/2025 to 06:59 hours on 01/07/2025 and from 19:01 hours on</u> 01/07/2025 to 16:00 hours on 04/07/2025 on:

Horse Wynd: (i) *east side*, from the extended south kerbline of Abbey Strand, southwards for a distance of 39 metres or thereby; and (ii) *east and north sides*, from a point 20 metres or thereby west of the extended west kerbline of Queen's Drive, westwards and then northwards for a distance of 35 metres or thereby.

(B) *From 07:00 hours to 19:00 hours on 01/07/2025* on: **Horse Wynd**, *east side*, in its entirety.

SCHEDULE 3 PROHIBITION OF WAITING, LOADING AND UNLOADING

(A) <u>From 07:00 hours on 23/06/2025 to 06:59 hours on 01/07/2025 and from 19:01 hours on 01/07/2025 to 16:00 hours on 07/07/2025</u> on:

Holyrood Park Road, *north-west side*, from the extended north-east kerbline of Dalkeith Road, north-eastwards for a distance of 74 metres or thereby.

(B) From 07:00 hours on 24/06/2025 to 16:00 hours on 04/07/2025 on:

(i) **Abbeyhill**, *both sides*, from its junction with Canongate/Abbey Strand, northwards and then northwestwards to the west kerbline of Croft-An Righ; (ii) **Abbey Strand**; (iii) **Canongate**, *both sides*, from the extended east kerbline of Horse Wynd, south-westwards for a distance of 80 metres or thereby; (iv) **Croft-An-Righ**; (v) **Horse Wynd**, *west side*, in its entirety; and (vi) **North Approach**.

(C) From 07:00 hours to 19:00 hours on 01/07/2025 on:

(i) Abbey Mount; (ii) Canongate; (iii) High Street, *both sides*, from the extended west kerbline of Saint Mary's Street, westwards for a distance of 79 metres or thereby; (iv) Holyrood Gait; (v) Holyrood Park Road; and (vi) Holyrood Road.
