THE CITY OF EDINBURGH COUNCIL (GORGIE ROAD & STENHOUSE DRIVE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/87

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Gorgie Road & Stenhouse Drive) (Temporary Road Restriction and Traffic Regulation) Order 2025" and shall have effect on the thirtieth day of June Two thousand and twenty-five and shall remain in force up to and including the sixth day of August Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "bus lane" has the same meaning as in Section 44(4) of the Transport (Scotland) Act 2001; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the Greenway Order" means The City of Edinburgh Council (Greenways) Order 1997; and "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
- 3. Save as provided in Article 4 of this Order, to facilitate a safe working area for SGN Mains Replacement works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit any vehicle to be driven on *both sides* of **Stenhouse Drive**, from the north extended kerbline of Gorgie Road, northwards for a distance of 50 metres or thereby; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on *both sides* of: (i) Gorgie Road, from the east extended kerbline of Stenhouse Drive, eastwards to the west building line of number 560 Gorgie Road; and (ii) Stenhouse Drive, from the north extended kerbline of Gorgie Road, northwards for a distance of 50 metres or thereby.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The City of Edinburgh Council (Greenways) Order 1997 shall be suspended in relation to the greenways parking and loading bays, waiting and stopping, and bus lane restrictions in so far as they are affected by the restrictions specified in Article 3 of this Order.

6. The alternative route for through vehicular traffic with respect to the closure will be by way of Stenhouse Road, Stevenson Drive and Stenhouse Cross.
