THE CITY OF EDINBURGH COUNCIL (LEAMINGTON TERRACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/60

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Leamington Terrace Area) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect on the Fourteenth day of July Two thousand and twenty-five and shall remain in force up to and including the Tenth day of October Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate a safe working area for renewal of carriageway and gullies (as signed as affected by the works), no person shall: -
 - (a) drive or cause or permit to be driven any vehicle on any part of: (i) Leamington Terrace in its entirety; (ii) Westhall Gardens in its entirety; (iii) Admiral Terrace in its entirety; and (iv) Upper Gilmore Place in its entirety.
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on both sides unless otherwise stated: (i) Leamington Terrace in its entirety; (ii) Westhall Gardens from the south-west kerbline of Leamington Terrace south-westwards for a distance of 50 metres or thereby; & (iii) Upper Gilmore Place from its junction with Leamington Terrace to its junction with Gilmore Place.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. "The City of Edinburgh Council (Montpelier and Westhall Gardens, Edinburgh) (Prohibition of Vehicles and Prohibition of Entry) Traffic Regulation Order 2000" will be suspended for the duration of the works in relation to the prohibition of entry from Westhall Gardens into Viewforth, to facilitate two-way access.
- 6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

7. The alternative routes for through vehicular traffic with respect to the closures will be by way of: Bruntsfield Place, Viewforth and Gilmore Place.
