**THE EDINBURGH CORPORATION (KIRK STREET, CASSEL'S  
LANE AND WARRISTON ROAD) ONE-WAY TRAFFIC  
ORDER 1974**

The Corporation of the City of Edinburgh in exercise of the powers conferred on them by Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and of all other powers enabling them in that behalf and after consultation with the Chief Constable in accordance with Section 84 (c) of the said Act of 1967 hereby make the following Order:—

1. This Order may be cited as “The Edinburgh Corporation (Kirk Street, Cassel's Lane and Warriston Road) One-Way Traffic Order 1974” and shall come into operation on the 29th day of July 1974.
2. The Interpretation Act 1889 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. No person shall drive or cause or permit to be driven any vehicle on any of the lengths of road specified in Column I of the Schedule to this Order otherwise than in the direction specified opposite each length of road in Column II of the said Schedule.

### **THE CITY OF EDINBURGH COUNCIL (EDINBURGH TRAM) (PROHIBITION OF ENTRY, MOTOR VEHICLES AND TURNING, ONE-WAY ROADS, BUS/TRAM PRIORITY LANES AND WEIGHT LIMIT) TRAFFIC REGULATION ORDER 2023 - TRO/20/24A**

The City of Edinburgh Council in exercise of their powers under sections 1(1), 2(1) to (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, (which Act as so amended is hereinafter referred to as “the 1984 Act”), and of all other enabling powers, taking into account Section 122 of the Road Traffic Regulation Act 1984, and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as “The City of Edinburgh Council (Edinburgh Tram) (Prohibition of Entry, Motor Vehicles and Turning, One-Way Roads, Bus/Tram Priority Lanes and Weight Limit) Traffic Regulation Order 2023” and shall come into operation on the Thirteenth day of March Two Thousand and Twenty-three.

The Council is satisfied that, for facilitating the passage of vehicular traffic on the road, it is requisite that Section 3 (1) of the 1984 Act should not apply to this Order.

2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-

“Article” means an Article of this Order;

“bus lane” has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

“Chief Constable” means the Chief Constable for the Police Scotland area;

"Council" means the City of Edinburgh Council incorporated under the Local Government Etc. (Scotland) Act 1994 as local authority for the City of Edinburgh area;

"electronic communications apparatus" has the same meaning as in Section 32 of the Communications Act 2003;

"Executive Director of Place " means the Executive Director of Place of the Council;

"goods" means merchandise, produce and corporeal moveable items of a similar nature (excluding money) and "delivering" and "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;

"local authority" means a council constituted under Section 2 of the Local Government etc. (Scotland) Act 1994; “local service” has the meaning given in section 2 of the Transport Act 1985; “motor cycle” has the same meaning as in Section 136 of the 1984 Act;”

“motor vehicle” has the same meaning as Section 136 of the 1984 Act;

“parking attendant” has the same meaning as in Section 63A of the 1984 Act;

“pedal cycle” shall have the meaning assigned to that phrase by Section 151 of the Roads (Scotland) Act 1984;

“public service vehicle” shall have the meaning assigned to that phrase by Section 1 of the Public Passenger Vehicles Act 1981;

“road” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and for the avoidance of doubt, a road includes part of a road;

## **PROHIBITION OF MOTOR VEHICLES**

6. Save as provided in Article 7 of this Order, no person shall cause or permit any motor vehicle to enter, proceed or wait in or on any part of the lengths or areas of road described in column 1 of Schedule 2.
7. Nothing in Article 6 shall apply to any vehicle which is of one or more of the categories specified in column 2 of Schedule 2.
8. In column 2 of Schedule 2 the reference numbers utilised shall have the meanings assigned to them as are set out in the heading of Schedule 2.

## **PROHIBITION OF TURNING**

9. Save as provided in Article 10 of this Order, no person shall, except with the permission of a police constable in uniform or a traffic warden, drive or cause or permit to be driven any vehicle on the road specified in column 1 so as to make the prohibited turn specified in column 2, into the road specified in column 3 of Schedule 3.
10. Nothing in Article 9 shall apply to any vehicle which is of one or more of the categories specified in column 4 of Schedule 3.
11. In column 4 of Schedule 3 the reference numbers utilised shall have the meanings assigned to them as are set out in the heading of Schedule 3.

## **ONE-WAY ROADS**

12. Save as provided in Article 13 of this Order, no person shall, except with the permission of a police constable in uniform or a traffic warden, drive or cause or permit to be driven any vehicle on the lengths of road specified in column 1 otherwise than in the direction specified opposite to such road in column 2 of Schedule 4.
13. Nothing in Article 12 shall apply to any vehicle which is of one or more of the categories specified in column 3 of Schedule 4.
14. In column 3 of Schedule 4 the reference numbers utilised shall have the meanings assigned to them as are set out in the heading of Schedule 4.

## **TRAM LANES**

15. For the purposes of this Order a vehicle shall be deemed to be in, to have entered to remain in, or as the case may be, to be proceeding or waiting in a tram lane described in Schedule 5 if any part of the tram lane is directly below any part of the vehicle or its load.
16. Save as provided for in Articles 18, 20 and 21 no person shall cause or permit any vehicle to be in, to enter or proceed in a tram lane described in Schedule 5; Provided that nothing in this Article shall apply to any vehicle being in in a tram lane where the person in control of the vehicle is required by law to do so or is obliged to enter or proceed in a tram lane in order to avoid an accident, a parked vehicle or is prevented by circumstances outwith his control from avoiding entering or proceeding other than in the tram lane and as soon as possible causes the vehicle to leave the tram lane.
17. Save as provided in Articles 18 and 20 no person shall cause or permit any vehicle to wait in a tram lane described in Schedule 5; Provided that nothing in this Article shall render it unlawful to cause or permit any vehicle so to wait if the person in control of the vehicle is required by law to stop or is obliged to do so to avoid an accident or is prevented from proceeding by circumstances outwith his control and it is not reasonably practicable for him to drive or move the vehicle to a place outwith the tram lane.

## SCHEDULE 4

### MAIN TRAFFIC ROADS WHERE THERE ARE RESTRICTIONS ON MOVEMENT AND ENTRY

#### ONE-WAY ROADS

For the purposes of the application of this Order to any length of road specified in this Schedule the expression

The City of Edinburgh Council in exercise of the powers conferred on them by Sections 1(1), and 2(1) to (3) of the Road Traffic Regulation Act 1984, as amended, (which Act as so amended is hereinafter referred to as "the 1984 Act") and of all other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "The City of Edinburgh Council (Circus Lane, Edinburgh) (One-Way) Traffic Regulation Order 1999" and shall come into operation on the Twenty fifth day of October Nineteen hundred and Ninety nine.

2. In this Order:-

"Article" means an article of this Order;

"Chief Constable" means the Chief Constable for the Lothian and Borders police area;

"Schedule" means the Schedule to this Order;

3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.

4. No person shall except upon the direction or with the permission of a police constable in uniform or a traffic warden, drive or cause or permit any vehicle to be driven on the lengths of roads specified in column 1 of the Schedule to this Order otherwise than in the direction specified opposite in the corresponding line of column 2 of the said Schedule.

"mews retailer" means a retailer whose premises have a postal address in a road described in Schedule 5 to this Order or for those premises that have a physical boundary with a designated mews address, and either:

- a) where the said road is referenced by the prefix "5-M" in column 1 thereof; or
- b) where the parking place is otherwise identified as a residential mews.

"motor cycle" has the same meaning as in Section 136 of the 1984 Act;

"motor vehicle" has the same meaning as in Section 136 of the 1984 Act;

"nearside" in relation to a vehicle, means the left side of the vehicle viewed from the perspective of the driver sitting in the vehicle facing forwards;

"numbered parking place" means a parking place as described in Schedule 5 to this Order and either:

- a) referenced by the Prefix "5-M" in column one thereof; or
- b) otherwise identified as a residential mews.

"offside" in relation to a vehicle means the right side of the vehicle viewed from the perspective of the driver sitting in the vehicle facing forwards;

"one-way street" means a road in which the driving of vehicles otherwise than in one direction is prohibited;

"owner", in relation to a vehicle, means the registered keeper of the vehicle;

"parking attendant" has the same meaning as in Section 63A of the 1984 Act.

"parking bay" means an individual, separately marked space provided for the leaving of a single vehicle in a parking place, or part thereof, :

"parking charge" means the charge payable by any person leaving a vehicle in a parking place during the permitted hours in accordance with Article 4-1 of this Order;

"parking holiday" means Christmas Day (25 December), Boxing Day (26 December, unless 26 December falls on a Sunday, in which case 27 December shall be taken to be Boxing Day), New Year's Day (1 January) and Easter Monday;

"parking meter" has the same meaning as in Section 46(2) of the 1984 Act, being apparatus of a type and design approved by the Scottish Ministers for the purposes of this Order;

"parking place" means an area on a road described in Schedules 4, 5, 6 and 11 to 16 and 18 to 20 to this Order inclusive, (and for the avoidance of doubt includes a numbered parking place);

"passenger vehicle" means a motor vehicle (other than a motor cycle or invalid carriage) constructed or adapted solely for the carriage of not more than twelve passengers (exclusive of the driver) ;

"pedal cycle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;

"permit" means any permit issued by the Council under the terms of this Order and, for the avoidance of doubt, refers only to the original document as issued;

"permit holder" means any person to whom a permit has been issued by the Council under the terms of this Order;

"permitted hours", in relation to a parking place or a loading place or a taxi stance, means, as applicable, the period, or as the case may be, periods specified at the beginning of the respective sections or sub-sections of Schedules 4 to 6 inclusive and 11 to 21 inclusive to this Order;

"police vehicle" means a vehicle, whether or not mechanically propelled, which is being used by Lothian and Borders Police in the pursuance of duties being carried out under the direction of the Chief Constable;

"Priority Parking Area" means the area comprising the roads and the parking places which are so classified and specified in Sections 12 and 21 of Schedules 4, 5, 6, 7 and 8 to this Order;

"prohibited hours" means the period specified at the beginning of the respective sections of Schedule 1 or at the beginning of Schedule 2 to this Order: Provided that the expression "prohibited hours"

- (kk) A qualifying business vehicle displaying a valid business permit shall be exempt from the payment of any parking charges while waiting during the permitted hours in a parking place described in Sections 3-11 of Schedule 6. For the avoidance of doubt the exemption enacted by this article only applies within the zone for which the business permit was issued.
- (l) A qualifying tradesperson's vehicle displaying a valid trades' permit shall be exempt from the payment of any parking charge while waiting in a parking place described in Schedule 4 or Schedule 6, during the applicable permitted hours as described in the relevant sections of those Schedules.
- (m) Without prejudice to the generality of this Article, a vehicle to which this Article applies shall stand in the associated parking place in accordance with the provisions of Article 3-6.

#### **One-Way Streets**

##### ***One-way streets***

##### **8-1**

Except as provided in Articles 8-2 and 8-3 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, drive or cause or permit any vehicle to be driven on any of the lengths of road specified in column 1 of Schedule 3 otherwise than in the direction specified opposite to such road in column 2 of the said Schedule.

##### ***Exemption for mechanical road cleansing vehicles***

##### **8-2**

Nothing in Article 8-1 of this Order shall apply to the driving of a mechanical road-cleansing vehicle when being used between the hours of 5:00 am and 7:00 am.

##### ***Exemption for pedal cycles in certain lengths of road***

##### **8-3**

Nothing in Article 8-1 of this Order shall apply to the driving of pedal cycles in the lengths of road specified in Schedule 3 and there prefixed with the letters PC.

##### **9-1**

- (2) The provisions in the Orders specified in Schedule 25 shall have effect, subject to the amendments specified in that Schedule, from the dates of operation specified in the said Article 1-1 for the coming into operation of the respective Parts, Sections and Zones, and Schedules of this Order.

1. This Order may be cited as "The Lothian Regional Council (Richmond Lane, Edinburgh) (One-Way) Traffic Regulation Order 1992" and shall come into operation on the Eleventh day of January Nineteen hundred and Ninety three.
2. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made under the 1984 Act or by or under any other enactment.
3. No person shall except upon the direction or with the permission of a police constable in uniform or a traffic warden, drive or cause or permit any vehicle to be driven on the length of road specified in column 1 of the Schedule to this Order otherwise than in the direction specified opposite in column 2 of the said Schedule.

3. This Order may be cited as the "Edinburgh Corporation (Rose Street, one-way) (Traffic Regulation) Order, 1935."

THE CITY OF EDINBURGH COUNCIL (CENTRAL EDINBURGH) (PROHIBITION OF ENTRY AND TURNING, ONE-WAY ROADS AND BUS LANES) TRAFFIC REGULATION ORDER 2004  
- TRO/02/25A

The City of Edinburgh Council in exercise of their powers under sections 1(1), 2(1) and (3) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, (which Act as so amended is hereinafter referred to as “the 1984 Act”), and of all other enabling powers and after consultation with the Chief Constable in accordance with part III of Schedule 9 to the 1984 Act, hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Central Edinburgh) (Prohibition of Entry and Turning, One-Way Roads and Bus Lanes) Traffic Regulation Order 2004” and shall come into operation on the Sixteenth day of October Two Thousand and five.
2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them: -

“Article” means an Article of this Order;

“bus lane” means any part of a roadway indicated by a traffic sign of the form and dimensions as set out in diagram 1048 in Schedule 2 to the Traffic Signs Regulations and General Directions 1981 and which is bounded on the one side by the nearside edge of the carriageway and on the other by a longitudinal solid white line of the form and dimensions as set out in diagram 1049 in said Schedule 2;

“Chief Constable” means the Chief Constable of the Police Authority for the Lothian and Borders police area;

"Director of Services for Communities" means the Director of Services for Communities of The City of Edinburgh Council;

“disabled persons’ bus” means a vehicle constructed or adapted to carry two or more disabled persons, excluding the driver of the vehicle;

“goods” includes postal packets of any description; and “delivery” and “collecting” in relation to any goods include checking the goods for the purpose of their delivery or collection;

“goods vehicle” means a mechanically propelled vehicle constructed or adapted for the use of carriage of goods or burden of any description;

“local authority” means The City of Edinburgh Council;

“motor cycle” has the same meaning as in Section 136 of the 1984 Act;

"parking attendant" has the same meaning as in Section 63A of the 1984 Act;

“pedal cycle” shall have the meaning assigned to that phrase by Section 151 of the Roads (Scotland) Act 1984;

“permitted hours” in so far as it relates to Parts A and B of Schedule One and Part A and B of Schedule Two mean 6:00 pm until 8:00 am the following day on Mondays to Sundays inclusive.



19. Nothing in Article 16 shall apply to motor vehicles while being used for fire brigade, ambulance or police purposes in so far as the prohibition relates to the roads specified in items 1, 2, 4, 5, 6, 7, 10, 11, 13, 14, 15, 16, 19, 23, 24, 27 and 28.
20. Nothing in Article 16 shall apply to taxis in so far as the prohibition relates to the roads specified in items 10, 11, 13, 14, 15, 16, 19, 24, 27 and 28.
21. Nothing in Article 16 shall apply to public service vehicles in so far as the prohibition relates to the roads specified in items 10, 11, 13, 14, 15, 16, 19, 24, 27 and 28.
22. Nothing in Article 16 shall apply to disabled persons' buses in so far as the prohibition relates to the roads specified in items 10, 11, 13, 14, 15, 16, 19, 24, 27 and 28.

### **ONE-WAY ROADS**

23. Save as provided in Article 23A of this Order, no person shall, except with the permission of a police constable in uniform or a traffic warden, drive or cause or permit to be driven any vehicle on the lengths of road specified in column 1 of Schedule Three otherwise than in the direction specified opposite to such road in column 2 of said Schedule.
- 23A. Nothing in Article 23 shall apply to pedal cycles in so far as the prohibition relates to the roads specified in item 13 of Schedule Three.

### **BUS LANES**

24. For the purposes of this Order a vehicle shall be deemed to be in, to have entered to remain in, or as the case may be, to be proceeding or waiting in a bus lane described in Schedule Four to this Order if any part of said bus lane is below the vehicle or its load.
25. Save as provided in Article 27, 29 and 30 no person shall:-
  - (a) between the hours of 7:30 am and 9:30 am and between 4:00pm and 6:30 pm Mondays to Fridays both inclusive, cause or permit any vehicle to be in, to enter or proceed in a bus lane described in Part A of Schedule Four to this Order, or
  - (b) between the hours of 8:00 am and 9:15 am and between 4:30 pm and 6:00 pm Mondays to Fridays, cause or permit any vehicle to be in, to enter or proceed in a bus lane described in Part B of Schedule Four to this Order.

Provided that nothing in this Article shall apply to any vehicle being in a bus lane where the person in control of the vehicle is required by law to do so or is obliged to enter or proceed in a bus lane in order to avoid an accident, a parked vehicle or is prevented by circumstances out with his control from avoiding entering or proceeding other than in the bus lane and as soon as possible cause the vehicle to leave the bus lane.

26. Not allocated.
27. Nothing in Articles 25 and 26 shall apply to:-
  - (i) a public service vehicle;
  - (ii) a vehicle being used for fire brigade, ambulance or police purposes if it is reasonably necessary for that vehicle to enter, proceed or wait in a bus lane described Schedule Four;

### THE CITY OF EDINBURGH COUNCIL (SIMPSON LOAN, EDINBURGH) (PROHIBITION OF ENTRY) TRAFFIC REGULATION ORDER 2012 - TRO/11/51A

The City of Edinburgh Council in exercise of their powers under Sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984, as amended (which Act as so amended is hereinafter referred to as "the 1984 Act") and of all other enabling powers and after consultation with the Chief Constable in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

1. This Order may be cited as "The City of Edinburgh Council (Simpson Loan, Edinburgh) (Prohibition of Entry) Traffic Regulation Order 2012" and shall come into operation on the Thirtieth day of July Two thousand and twelve.

2. In this Order:-

"Article" means an article of this Order;

"police constable" means a police constable for the Lothian and Borders police area;

"traffic warden" means an officer employed by the police authority as a traffic warden in pursuance of Section 9 of the Police (Scotland) Act 1967.

"Schedule" means the Schedule to this Order;

"telecommunication apparatus" shall have the meaning assigned to that phrase by Section 4 of and Schedule 2 to the Telecommunications Act 1984;

"traffic sign" means a sign of any size, colour and type prescribed or authorised under or having effect as though prescribed or authorised under Section 64 of the 1984 Act and includes any line or mark on a road for conveying warnings, information, requirements, restrictions or prohibitions.

3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment.
4. Save as provided in Article 5 no person shall, except upon the direction or with the permission of a police constable in uniform or a traffic warden, drive or cause or permit to be driven any vehicle on the road specified in column 1 of the Schedule so as to enter the road specified in the corresponding line of column 2 of said Schedule.

5. The prohibition imposed by Article 4 shall not apply to:-

(a) a vehicle while being used in an emergency for fire brigade, ambulance or police purposes;

(b) a vehicle while being used in connection with any building operation, demolition or excavation in or adjacent to the lengths of road, the cleansing or lighting of the lengths

of road, the maintenance, improvement or reconstruction of the lengths of road or street furniture therein or thereon, the laying, erection, alteration or repair in or adjacent to the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus, or the placing, maintenance or removal of any traffic sign.
