THE CITY OF EDINBURGH COUNCIL (WARDIE ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/110

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

1. This Order may be cited as “The City of Edinburgh Council (Wardie Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025”. The Order shall have effect on the Twenty-eighth day of July Two thousand and twenty-five and shall remain in force up to and including the Thirty-first day of August Two thousand and twenty-five.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate a safe working area for SGN to carry out the replacement of a critical metallic stub (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of **Wardie Road**, from the extended south kerbline of Afton Terrace, southwards for a distance of 20 metres or thereby; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of: (i) **Wardie Road, both sides**, from the extended south kerbline of Afton Terrace, southwards for a distance of 20 metres or thereby; (ii) **Afton Terrace, both sides**, from the extended west kerbline of Wardie Road, westwards for a distance of 45 metres or thereby; and (iii) **Cargil Terrace, both sides**, from the extended east kerbline of Wardie Road, eastwards for a distance of 40 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The alternative route for through vehicular traffic in relation to the **road closure** of **Wardie Road** will be by way of: (i) Cargil Terrace, South Trinity Road, Darnell Road and Wardie Road; and (ii) Afton Terrace, Granton Road, Rosebank Road and Wardie Road.
