Introduction

Your August 2025 payslip will reflect an uplift in your salary and other payments for August, and it'll also include back-pay for the four months between April and July 2025. The following guidance explains how this will look on your August 2025 payslip.

Back-pay due – April to July 2025

Back-pay calculated for basic pay and other pay elements for the period between April to July is:

- 1. Displayed under the 'Earnings' header on your payslip
- 2. Recorded as 'Retroactive' entries.

If you received a manual adjustment to your pay between April and July, processed under the element "Misc Adjust 299", you'll see any back pay due for this:

- 1. Displayed under the 'Other Earnings' header further down your payslip
- 2. Recorded as a single entry under 'Misc Adjust 299'.
