## DSDP Foundation Online Training Course

Training will be delivered online in a series of four, live presentations with a trainer. After attending all presentations, you will be invited to attend a multiple choice assessment at the Licensing Hub, 33 Murrayburn Road Edinburgh, EH14 2TF.

Passing the assessment is a requirement prior to the grant of a Taxi or Private Hire Car Driver licence.

Information on this page may be a useful guide of what to expect on the day of the assessment.

**1. How will the assessment be delivered?**

- a. The assessment is completed in-person at the Licensing Hub, 33 Murrayburn Road Edinburgh, EH14 2TF

**2. How long will the assessment last?**

- a. The assessment will last for 45 minutes

**3. Is the assessment open or closed book?**

- a. The assessment is closed book - meaning you cannot refer to any books or notes and the use of phones or electronic devices are prohibited during the assessment

**4. What type of questions are in the assessment?**

- a. There are a series of multiple choice questions - based on subjects covered in the online presentations, the foundation course training workbook and licensing conditions documents

**5. What is the pass mark for the assessment?**

- a. You will need to achieve a score of 75% or more correct answers to pass

**6. How long will it take to find out if I passed?**

- a. The results will be communicated to you within 2 weeks

**7. What happens if I pass the assessment?**

- a. A certificate of achievement will be posted to the home address given on this booking form
- b. If you have submitted your Licence application, or at the time when you do so, the licensing database will be updated to record the successful completion of your training

**8. What happens if I fail the assessment?**

- a. You will have an opportunity to re-sit a different test at a future date
