THE CITY OF EDINBURGH COUNCIL (MARCHMONT ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/112

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Marchmont Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect on the Fourth day of August Two thousand and twenty-five and shall remain in force up to and including the Twenty-sixth day of September Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;
  - "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate Scottish Power cabling works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on any part of **Spottiswoode Road**, from its junction with Marchmont Road, westwards to the extended east kerbline of Arden Street:
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of: (i) **Beaufort Road**, *both sides*, from the extended east kerbline of Marchmont Road, eastwards for a distance of 65 metres or thereby; (ii) **Marchmont Crescent**, *both sides*, from the extended east kerbline of Marchmont Road, north-eastwards for a distance of 65 metres or thereby; (iii) **Marchmont Road**, *both sides*, from the extended north kerbline of Beaufort Road, northwards for a distance of 200 metres or thereby; and (iv) **Spottiswoode Road**, *both sides*, from the extended west kerbline of Marchmont Road, westwards for a distance of 80 metres or thereby;
  - (c) except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the length of road specified in column 1 of Schedule 1, otherwise than in the direction specified in column 2 of the said Schedule; and
  - (d) except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the road specified in column 1 of Schedule 2, so as to make the prohibited turn specified in column 2, into the road specified in column 3 of the said Schedule.
- 4. Nothing in:
  - (a) Article 3 shall apply to emergency service vehicles.
  - (b) Article 3 (a) and (b) shall apply to vehicles in actual use with the undertaking of the

- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 6. The alternative route for through vehicular traffic in relation to:
  - (a) the *road closure* of **Spottiswoode Road** will be by way of Marchmont Road, Warrender Park Road and Arden Street;
  - (b) the *one-way road* on Marchmont Road will be by way of: (i) Marchmont Road, Melville Drive, Summerhall, Causewayside, Grange Road, Beaufort Road and Marchmont Road; and (ii) Marchmont Road, Melville Drive, Brougham Place, Brougham Street, Home Street, Leven Street, Gillespie Place, Bruntsfield Place, Chamberlain Road, Greenhill Gardens, Strathearn Place, Strathearn Road, and Marchmont Road;
  - (c) the *prohibition of turning* on **Thirlestane Lane** will be by way of Marchmont Road, Thirlestane Road, Whitehouse Loan, Strathearn Road and Marchmont Road; and
  - (d) the *prohibition of turning* on **Thirlestane Road** will be by way of Marchmont Road, Warrender Park Road, Whitehouse Loan, Strathearn Road and Marchmont Road.
