

The City of Edinburgh Council hereby give notice under Section 14(2)(b) of the Road Traffic Regulation Act 1984, as amended, that for the reason set out in Section 14(1)(b) of that Act, to ensure the safety of the public and all those involved in the Fringe Street Events no person shall:

Drive or cause or permit to be driven any vehicle on the roads listed (where prohibitions apply to roads in their entirety unless otherwise stated), between the times and dates stated below, or as directed by a constable in uniform:

- Mondays to Saturdays between 01/08/25 & 23/08/25 Daily, from 10:30hrs to 19:00hrs:
- Sundays 03/08/25, 10/08/25, 17/08/25, 24/08/25 from 10:30hrs to 21:00hrs:

Except with the permission of a parking attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the roads listed (where prohibitions apply to both sides of the roads in their entirety unless otherwise stated) between the times and dates stated below:

• From 06:00hrs on 29/7/25 to 19:00hrs on 26/08/25

From a point 30m east of the junction with Bank Street (at the National Barrier Asset) to High Street (except loading daily from 0001hrs to 1030hrs and except authorised vehicles displaying the appropriate accredited pass – Fringe prior to 1900hrs and Tattoo after 1900hrs daily).
6	Cockburn Street	In its entirety (except loading daily from 0001hrs to 1030hrs).
