## THE CITY OF EDINBURGH COUNCIL (SILVERKNOWES ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/95

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Silverknowes Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect on the Eleventh day of August Two thousand and twenty-five and shall remain in force up to and including the Seventh day of September Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order:
  - "Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "motor vehicle" has the same meaning as in Section 136 of the Road Traffic Regulations Act 1984:
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "road" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;
  - "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate planned alterations to the Travelling Safely installation (as signed as affected by the works), no person shall:-
  - (a) except upon the direction of a police constable in uniform, cause or permit any motor vehicle to enter into, remain, or proceed in or on part of any length of road specified in Schedule 1; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on the sections of roads specified in Schedule 2.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative route for through general vehicular traffic with respect to the **Prohibition of Motor Vehicles** will be by way of: Silverknowes Road, Silverknowes Road East, Silverknowes Drive and Silverknowes Road (service road south of Silverknowes Crescent, southern junction).

## SCHEDULE 1 PROHIBITION OF MOTOR VEHICLES

Silverknowes Road (service road, south of Silverknowes Crescent, southern junction)	All that part of the carriageway from the extended south kerbline of Silverknowes Crescent (southern junction), southwards for a distance of 20 metres or thereby.

# SCHEDULE 2 PROHIBITION OF WAITING, LOADING AND UNLOADING

## (i) Marine Drive

**south side,** (1) from the extended east kerbline of Silverknowes Road, eastwards for a distance of 41 metres or thereby; and (2) from the extended west kerbline of Silverknowes Road, westwards for a distance of 31.5 metres or thereby; and

*north side* from a point 61 metres or thereby west of the extended west kerbline of Silverknowes Road, eastwards for a distance of 106 metres or thereby.

## (ii) Silverknowes Court (northern junction)

*both sides*, from the extended east kerbline of Silverknowes Road, eastwards for a distance of 11 metres or thereby.

### (iii) Silverknowes Court (north leg)

*north side*, (1) from the extended west kerbline of Silverknowes Place, westwards for a distance of 10 metres or thereby; and (2) from the extended east kerbline of Silverknowes Place, eastwards for a distance of 7.5 metres or thereby; and

**south side** from a point 9.5 metres or thereby west of the extended west kerbline of Silverknowes Place, eastwards for a distance of 19.5 metres or thereby.

### (iv) Silverknowes Court (southern junction)

*both sides*, from the extended east kerbline of Silverknowes Road, eastwards for a distance of 13 metres or thereby.

## (v) Silverknowes Crescent (northern junction)

*both sides,* from the extended west kerbline of Silverknowes Road, westwards for a distance of 8.5 metres or thereby.

## (vi) Silverknowes Crescent (southern junction)

**both sides,** from the extended west kerbline of Silverknowes Road, westwards for a distance of 10 metres or thereby.

#### (vii) Silverknowes Drive

**both sides**, from the extended west kerbline of Silverknowes Road East, westwards for a distance of 7 metres or thereby.

## (viii) Silverknowes Hill (northern junction)

**both sides,** from the extended west kerbline of Silverknowes Road, westwards for a distance of 10 metres or thereby.

## (ix) Silverknowes Hill (southern junction)

**both sides**, from the extended west kerbline of Silverknowes Road, westwards for a distance of 10 metres or thereby.

#### (x) Silverknowes Parkway

**south side,** (1) from the east kerbline of Silverknowes Place, eastwards to the west kerbline of Silverknowes Parkway (access road to 40-66); and (2) from the extended west kerbline of Silverknowes Place, westwards for a distance of 45 metres or thereby.

## (xi) Silverknowes Parkway (access road to 40-66)

*west side*, from the south kerbline of Silverknowes Parkway (main carriageway), southwards for a distance of 7 metres or thereby.

#### (xii) Silverknowes Place

*west side*, from the extended south kerbline of Silverknowes Parkway, southwards for a distance of 14 metres or thereby;

*east side*, from the extended south kerbline of Silverknowes Parkway, southwards for a distance of 11 metres or thereby; and

*both sides*, from the extended north kerbline of Silverknowes Court, northwards for a distance of 11 metres or thereby.

#### (xiii) Silverknowes Road

east side, (1) from the south kerbline of Marine Drive, southwards and then south-eastwards to the north kerbline of Silverknowes Court, including the roundabout at the junction of Silverknowes Parkway; (2) from the south kerbline of Silverknowes Court (northern junction), southwards for a distance of 26 metres or thereby; (3) from the north kerbline of Silverknowes Court (southern junction), northwards for a distance of 18 metres or thereby; (4) from the south kerbline of Silverknowes Court (southern junction), southwards to the point Silverknowes Road adjoins Silverknowes Road East; and

west side, (1) from the south kerbline of Marine Drive, southwards and then south-eastwards to the north kerbline of Silverknowes Crescent (northern junction), including the roundabout at the junction of Lauriston Farm Road; (2) from the south kerbline of Silverknowes Crescent (northern junction), southwards to the north kerbline of Silverknowes Hill (northern junction); (3) from the south kerbline of Silverknowes Hill (southern junction); (4) from the south kerbline of Silverknowes Hill (southern junction), southwards to the north kerbline of Silverknowes Crescent (southern junction).

(xiv) Silverknowes Road (service road south of Silverknowes Crescent, southern junction) *east side*, from the apex of the traffic island (south of Silverknowes Crescent, southern junction), southwards for a distance of 8.5 metres or thereby; and

*west side,* from the south kerbline of Silverknowes Crescent (southern junction), southwards for a distance of 13.5 metres or thereby.

#### (xv) Silverknowes Road East

*east side*, from the point Silverknowes Road adjoins Silverknowes Road East, southwards to a point 45 metres or thereby north of the extended most southern building line of 56 Silverknowes Road East; and

west side, (1) from the apex of the traffic island adjacent to Silverknowes Road (service road south of Silverknowes Crescent, southern junction), southwards to the north kerbline of Silverknowes Drive; and (2) from the south kerbline of Silverknowes Drive, southwards for a distance of 32 metres or thereby.
