THE CITY OF EDINBURGH COUNCIL (PARKHEAD LOAN AND PARKHEAD TERRACE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/115

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Parkhead Loan and Parkhead Terrace) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect on the Twenty-second day of August Two thousand and twenty-five and shall remain in force up to and including the Twelfth day of September Two thousand and twenty-five
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate a safe working area for SPEN power mains replacement works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on any part of **Parkhead Loan**, from the extended south-west kerbline of Longstone Road, south-westwards to the extended north-east kerbline of Parkhead Terrace; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of: (i) **Parkhead Loan**, *both sides*, from the extended south-west kerbline of Longstone Road, south-westwards to the extended south-west building line of numbers 27/29 Parkhead Loan; and (ii) **Parkhead Terrace**, *both sides*, from the extended north-west kerbline of Parkhead Loan, north-westwards to the extended south-east building line of numbers 39/41 Parkhead Terrace.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic in relation to the *road closure* of **Parkhead Loan** will be by way of: (i) Longstone Road, Murrayburn Road, Parkhead Drive and Parkhead Loan; and (ii) Longstone Road, Calder Road, Sighthill Avenue, Parkhead Avenue, Parkhead Gardens, Parkhead Drive and Parkhead Loan.
