

ROADS (SCOTLAND) ACT 1984

The City of Edinburgh Council proposes to make an Order under sections 1(1) and 152(2) of the Roads (Scotland) Act 1984 redetermining the roads described in the Schedules hereto. The title of the Order is "The City of Edinburgh Council (West Craigs Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202_" - RSO/24/21. A copy of the proposed Order and the accompanying plans showing the roads over which the means of exercise of the public right of passage are to be redetermined, together with a statement of the reasons for making the Order can be viewed free of charge at the City of Edinburgh Council, Waverley Court Reception, between 09.30 and 15.30 from **05/09/25** to **03/10/25** or online during the same period at www.edinburgh.gov.uk/trafficorders and www.tellmescotland.gov.uk. SCHEDULE 1 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO CYCLE TRACK **Blaikie St** (i) (both sides) See Turnhouse Rd item (iv); **Turnhouse Rd** (i) All that part of the carriageway on the north-east side of Turnhouse Rd, from 95m south-east of the intersection of the extended south-east kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 11.6m and which has a width throughout of 1.7m; (ii) All that part of the carriageway on the south-west and north-east sides of Turnhouse Rd, from 156.2m south-east of the intersection of the extended south-east kerbline of Craigs Rd and the south-west kerbline of Turnhouse Rd, south-eastwards for 104.5m and which has a width that varies from 0m to 6.5m, excluding the adjacent verges; (iii) All that part of the carriageway on the north-east side of Turnhouse Rd, from 17.3m south-east of the intersection of the extended south-east kerbline of Meadowfield Rd Nth and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 8m and which has a width throughout of 1.8m; (iv) All that part of the carriageway on the south-west side of Turnhouse Rd and both sides of Blaikie St, from 2.9m north-west of the intersection of the extended north-west kerbline of Blaikie St and the extended south-west kerbline of Turnhouse Rd, south-eastwards for 14.1m and which has a width that varies from 0m to 10.1m; (v) All that part of the carriageway on the north-east side of Turnhouse Rd, from 82.2m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 10m and which has a width throughout of 1.9m; (vi) All that part of the carriageway on the north-east side of Turnhouse Rd, from 271.5m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 8.1m and which has a width throughout of 1.9m.

SCHEDULE 2 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CYCLE TRACK **Turnhouse Rd** (i) All that part of the footway on the north-east side of Turnhouse Rd, from 95m south-east of the intersection of the extended south-east kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 11.6m and which has a width throughout of 1.9m; (ii) All that part of the footway on the north-east side of Turnhouse Rd, from 223.4m south-east and 2m south-west of the intersection of the extended south-east kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 5.5m and which has a width that varies from 0 to 1.5m; (iii) All that part of the footway on the north-east

side of Turnhouse Rd, from 17.3m south-east of the intersection of the extended south-east kerbline of Meadowfield Rd Nth and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 8m and which has a width throughout of 2.4m; (iv) All that part of the footway on the north-east side of Turnhouse Rd, from 82.2m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 10m and which has a width throughout of 1.9m; (v) All that part of the footway on the north-east side of Turnhouse Rd, from 271.5m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 8.1m and which has a width throughout of 1.4m. **SCHEDULE 3 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY Turnhouse Rd** (i) All that part of the footway on the north-east side of Turnhouse Rd, from 194.8m south-east of the intersection of the extended south-east kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 63.1m and which has a width that varies from 0m to 2m; excluding the adjacent verge; (ii) All that part of the footway on the north-east side of Turnhouse Rd, from 6.1m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 10m and which has a width that varies from 0m to 2m; (iii) All that part of the footway on the north-east side of Turnhouse Rd, from 236.1m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 8.7m and which has a width that varies from 0m to 1.6m. **SCHEDULE 4 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY Craigs Rd** (i) All that part of the carriageway on the north side of Craigs Rd, from 71m west of the intersection of the extended west kerbline of Bradshaw Dr and the north kerbline of Craigs Rd, eastwards for 17m and which has a width that varies from 1.5m to 1.1m; (ii) All that part of the carriageway on the north side of Craigs Rd, from 104.2m west of the intersection of the extended west kerbline of MacDermott Way and the north kerbline of Craigs Rd, eastwards for 12.8m and which has a width that varies from 2.3m to 0m; (iii) (north-west side) See Turnhouse Rd item (i); (iv) (south-east side) See Turnhouse Rd item (ii); **Glassbrook Ave** (i) All that part of the carriageway on the east side of Glassbrook Ave, from the intersection of the extended north-west kerbline of Blaikie St and the extended east kerbline of Glassbrook Ave, north-westwards for 42.3m and which has a width that varies from 2m to 0m; **Turnhouse Rd** (i) All that part of the carriageway on the north-east side of Turnhouse Rd and the north-west side of Craigs Rd, from the intersection of the extended north-west kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, north-westwards for 40.4m and which has a width that varies from 0m to 3m; (ii) All that part of the carriageway on the north-east side of Turnhouse Rd and the south-east side of Craigs Rd, from the intersection of the extended south-east kerbline of Craigs Rd and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 95m and which has a width that varies from 0m to 2.8m; (iii) All that part of the carriageway on the north-east side of Turnhouse Rd, from 6.3m north-west of the intersection of the extended south-east kerbline of Meadowfield Rd Nth and the extended north-east kerbline of Turnhouse Rd, north-westwards for 52m and which has a width that varies from 4m to 0m; (iv) All that part of the carriageway on the north-east side of Turnhouse Rd, from the intersection of the extended south-east kerbline of Meadowfield Rd Nth and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 17.3m and which has a width that varies from 0m to 1.8m; (v) All that part of the carriageway on the north-east side of Turnhouse Rd, from 25.3m south-east of the intersection of the extended south-east kerbline of

Meadowfield Rd Nth and the extended north-east kerbline of Turnhouse Rd, south-eastwards for 38.4m and which has a width that varies from 1.8m to 0m;

(vi) All that part of the carriageway on the north-east side of Turnhouse Rd, from 6.1m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, north-westwards for 53.9m and which has a width that varies from 0m to 1.9m;

(vii) All that part of the carriageway on the north-east side of Turnhouse Rd, from 16.1m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 66.1m and which has a width that varies from 0m to 1.9m;

(viii) All that part of the carriageway on the north-east side of Turnhouse Rd, from 92.2m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 71.5m and which has a width that varies from 3m to 0m;

(ix) All that part of the carriageway on the north-east side of Turnhouse Rd, from 181.3m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 54.8m and which has a width that varies from 0m to 1.9m;

(x) All that part of the carriageway on the north-east side of Turnhouse Rd, from 244.8m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 26.7m and which has a width that varies from 0m to 1.9m;

(xi) All that part of the carriageway on the north-east side of Turnhouse Rd, from 279.6m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 30.9m and which has a width that varies from 1.9m to 0m;

(xii) All that part of the carriageway on the north-east side of Turnhouse Rd, from 317.2m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 24.2m and which has a width that varies from 0m to 1.9m;

(xiii) All that part of carriageway on the north-east side of Turnhouse Rd, from 352.7m south-east of the intersection of the extended north-west kerbline of Blaikie St and the north-east kerbline of Turnhouse Rd, south-eastwards for 6.2m and which has a width that varies from 2.2m to 0m;

(xiv) All that part of the carriageway on the south-west side of Turnhouse Rd, from 224.8m north-west of the intersection of the extended north-west kerbline of West Craigs Cres and the south-west kerbline of Turnhouse Rd, south-eastwards for 64.4m and which has a width that varies from 0m to 1.5m;

(xv) All that part of the carriageway on the south-west side of Turnhouse Rd, from 154m north-west of the intersection of the extended north-west kerbline of West Craigs Cres and the south-west kerbline of Turnhouse Rd, south-eastwards for 4.5m and which has a width that varies from 2.1m to 1.8m; and

(xvi) All that part of the carriageway on the south-west side of Turnhouse Rd, from 141.7m north-west of the intersection of the extended north-west kerbline of West Craigs Cres and the south-west kerbline of Turnhouse Rd, south-eastwards for 121.5m and which has a width that varies from 0m to 1.9m.
