THE CITY OF EDINBURGH COUNCIL (LONDON ROAD/LEOPOLD PLACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/108

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (London Road/Leopold Place Area) (Temporary Road Restriction and Traffic Regulation) Order 2025" and shall have effect on the twenty-second day of September Two thousand and twenty-five and shall remain in force up to and including the twenty-first day of November Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
- 3. Save as provided in Article 4 and 5 of this Order, to facilitate carriageway resurfacing and footway works (as signed as affected by the works), no person shall:-
 - (a) except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven otherwise than in a west to east direction on **Leopold Place/London Road** between Leith Walk and Hillside Crescent (*east leg*);
 - (b) drive or cause or permit any vehicle to be driven on any part of: (i) **London Road** (south side) at its junction with Hillside Crescent (east leg); (ii) **Leopold Place/London Road** (north side) from its junction with Leith Walk, eastwards to its junction with Hillside Crescent (east leg); (iii) **Windsor Street** at its junction with Leopold Place; and (iv) **Blenheim Place** at its junction with Leopold Place; and
 - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of **both sides** of: (i) **Leopold Place/London Road** between its junction with Leith Walk and its junction with Hillside Crescent (*east leg*); and (ii) **Blenheim Place** from the east kerbline of Leopold Place southwards and then eastwards for a distance of 70 metres or thereby.
- 4. Nothing in Article 3(a) and 3(b) (ii) shall be enacted at the same time.
- 5. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.

- 7. The alternative route for through vehicular traffic in relation to:
 - (a) the *one-way road* on **Leopold Place/London Road** will be by way of Easter Road, Regent Road, Waterloo Place, Leith Street, Picardy Place and Leith Walk;
 - (b) the road closures will be by way of: (i) London Road, Easter Road, Regent Road, Waterloo Place, Leith Street, Picardy Place and Leith Walk; (ii) Leopold Place/London Road, Easter Road, Regent Road, Waterloo Place, Leith Street, Picardy Place and Leith Walk; (iii) Windsor Street, Windsor Street, Montgomery Street, Brunswick Street, Hillside Crescent and London Road; and (iv) Blenheim Place, Blenheim Place, Royal Terrace, Carlton Terrace, Easter Road and London Road.
- 8. 'The Lothian Regional Council (London Road, Edinburgh) (Bus Priority Lanes Etc) Traffic Regulation Order 1979' will be suspended in relation to the bus lanes on London Road in so far as they are affected by the restrictions specified in Article 3(a) and 3(b) (i) and (ii) of this Order.
