The Edinburgh Child Protection Committee is committed to ensuring we have a suitably skilled, confident, competent and supported workforce to meet the needs of children and young people in the city. We do this through our Multi-Agency Child Protection Learning and Development Strategy and the work of our Learning and Development Sub-Committee, as well as supporting single-agency learning and other continuous improvement strategies.

In April 2025 we launched <u>mylearninghub.events</u> where staff and volunteers from across the partnership can explore free open-access learning. City of Edinburgh Council staff will continue to find all the same courses and learning opportunities on <u>My Learning Hub</u>.

Contextual Safeguarding - Risks Outside the Home (ROTH)

At October's Child Protection Committee, committee members will be discussing and hopefully agreeing the Contextual Safeguarding - Risks Outside the Home Guidance, which our Child Exploitation Oversight Sub-Committee has been working on for several months.

Further, the Committee is delighted to be partnering with City of Edinburgh Council in addressing child trafficking and exploitation by embedding Contextual Safeguarding approaches across the services. This will be aided by a range of Contextual Safeguarding training, delivered by Power the Fight, offered from **October 2025 – March 2026**. Child Protection and Alcohol and Drug Partnership Webinars

We are continuing a series of webinar's that will highlight the local risks of alcohol and drug use. This is a partnership between the Edinburgh public protection committees.

Family Group Decision Making

When a family is in crisis, we can often support them best by bringing together extended networks of informal support to build a plan. City of Edinburgh's Family Group Decision Making Team are offering a series of information sessions to explain more about the principles and values of the work. IRD Workshop

We strive for Intensive Contact staff to be confident in addressing complex and cross-cutting environmental, family and individual factors and consider across the agencies how they may contribute to increased risk of harm. This often includes identification/assessment of risk and developing, recording, monitoring and reviewing safety plans within Child Protection investigations. As such, we offer opportunities for Inter-Agency Referral Discussion Practitioners to meet and explore key themes and issues in dedicated workshops.

The next one takes place on **Friday 31**st **October 9.00am-1.00pm** at the Business Centre, City Chambers. This will focus on learning from audits and data, new guidance and tools we are embedding to help the process and an overview of the Scottish Child Interviewing Model and where it intersects with the IRD process. Young People Under Pressure

NSPCC have recently launched a new briefing on young people's mental health. This is based on the experiences of thousands of children and young people who make use of their helplines. You can find more information at NSPCC Learning.

Zero Tolerance, a domestic abuse charity, are also recognising the pressures on our young people, particularly around sex, relationships and gender. Youth workers, teachers, and other practitioners are in a key position to inform, support, and empower young people, yet can find these conversations awkward and uncomfortable. Their free Under Pressure training activates skills in talking to young people about these serious

Important Information about our Courses, Workshops and Events

All our events are free of charge at the point of delivery, and we don't fine you if can't attend at the last minute. They are not free to run, however. The Edinburgh Child Protection Committee funds learning through a multiagency budget to make it accessible to everyone who needs it. Also, facilitators and training leaders give their time and energy to deliver the learning. Many commit to this over and above their operational or practice roles.

Over the last year, we have seen a massive drop off between the individuals who booked on learning and those who attended and benefitted from the learning events. This is extremely wasteful as, other practitioners miss out on spaces, facilitators are sometimes delivering to half-empty rooms, and delegates don't get the chance to meet and share ideas with practitioners from other disciplines.

We are reviewing all the learning opportunities, attempting to offer new content and course options but if you book on a learning event and cannot attend, please hop on to mylearninghub.events and cancel your space.

Learning Reviews

Learning Review Protocol and Paperwork

Sometimes things go horribly wrong for the children and young people we work with. When this happens, the Edinburgh Child Protection Committee have systems for considering whether a Learning Review should take place. These used to be known as Significant Case Reviews (SCRs) but the model and approach has changed over the last few years.

In Edinburgh, we have conducted four Learning Reviews since 2023 and considered several other notifications for a Learning Review. Our Chief Officers often chose not to publish the full Learning Review reports, out of respect for children, young people and their families, who can sometimes be recognisable because of the level of detail in the Reports. We do usually publish an Executive Learning Summary, and these can be found on the Edinburgh Child Protection Committee pages.

You can find out all you need to know about the Learning Review process and how you or your service could notify of a possible Learning Review at the <u>Learning Reviews</u> pages. This system does not take away from other series incident recording and reviewing you may be involved in within your own agency and concerns should always be discussed in the first instance with your line manager.

The Learning Reviews process is never easy as it means a child has been significantly harmed or has died.
