

ROADS (SCOTLAND) ACT 1984

The City of Edinburgh Council proposes to make an Order under sections 1(1) and 152(2) of the Roads (Scotland) Act 1984 redetermining the roads described in the Schedules hereto. The title of the Order is "The City of Edinburgh Council (Leven Street Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202_" - RSO/25/14. A copy of the proposed Order and the accompanying plan showing the roads over which the means of exercise of the public right of passage are to be redetermined, together with a statement of the reasons for making the Order and our privacy notice can be viewed free of charge at the City of Edinburgh Council, Waverley Court Reception, between 09.30 and 15.30 from **10/10/25** to **07/11/25** or online during the same period at www.edinburgh.gov.uk/trafficorders and www.tellmescotland.gov.uk. Objections should state the name and address of the objector, the matters to which they relate and the grounds on which they are made.

SCHEDULE 1 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY

Leven St (East Side) (i) All that part of the footway on the east side of Leven St, from 8.4m south of the intersection of the extended south kerblines of Tarvit St and the extended east kerblines of Leven St, southwards for 4.9m and which has a width that varies from 0m to 0.5m; (ii) See Valleyfield St (south side) item (i); **Valleyfield St (South Side)** (i) All that part of the footway on the south side of Valleyfield St and the east side of Leven St, from the intersection of the extended south kerblines of Valleyfield St and the extended east kerblines of Leven St, eastwards for 10.9m and which has a width that varies from 0m to 1.5m.

SCHEDULE 2 ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED FROM CARRIAGEWAY TO FOOTWAY

Leven St (East Side) (i) All that part of the carriageway on the east side of Leven St and the south side of Tarvit St, from 8.4m south of the intersection of the extended south kerblines of Tarvit St and the extended east kerblines of Leven St, northwards for 8.4m then eastwards for 5.1m and which has a width that varies from 0m to 2m; (ii) All that part of the carriageway on the east side of Leven St from 13.3m south of the intersection of the extended south kerblines of Tarvit St and the extended east kerblines of Leven St, southwards for 16.6m and which has a width that varies from 0m to 2m; (iii) All that part of the carriageway on the east side of Leven St and the north side of Valleyfield St, from 11.6m north of the intersection of the extended north kerblines of Valleyfield St and the extended east kerblines of Leven St, southwards for 11.6m then eastwards for 7.3m and which has a width that varies from 0m to 2m; (iv) All that part of the carriageway on the east side of Leven St, from 1.75m north and 1.7m west of the intersection of the extended south kerblines of Valleyfield St and the extended east kerblines of Leven St, eastwards for 1.9m and which has a width that varies from 0.8m to 0.5m; (v) All that part of the carriageway on the east side of Leven St, from the intersection of the extended south kerblines of Valleyfield St and the extended east kerblines of Leven St, southwards for a distance of 10.1m and which has a width that varies from 2m to 0m; **Leven St (West Side)** (i) All that part of the carriageway on the west side of Leven St, from 28m south of the intersection of the extended south kerblines of Gilmore Pl and the extended west kerblines of Leven St, southwards for 8.1m and which has a width that varies from 5.4m to 0m; **Tarvit St (South Side)** (i) See Leven St (east side) item (i); **Valleyfield St (North Side)** (i) See Leven St (east side) item (iii); **Valleyfield St (South Side)** (i) All that part of the carriageway on the south side of Valleyfield St, from 1.75m north and 2.6m east of the intersection of the extended south kerblines of Valleyfield St and the extended east kerblines of Leven St, eastwards for a distance of 6.6m and which has a width throughout of 0.5m; and (ii) All that part of the carriageway on the south side of Valleyfield St, from a point 11.2m east of the intersection of the extended south kerblines of Valleyfield St and the extended east kerblines of Leven St, eastwards for a distance of 6.4m and which has a width that varies from 0m to 3.8m.
