

ROADS (SCOTLAND) ACT 1984

The City of Edinburgh Council proposes to make an Order under sections 1(1) and 152(2) of the Roads (Scotland) Act 1984 redetermining the roads described in the Schedule hereto. The title of the Order is "The City of Edinburgh Council (Telford Road Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202-" - RSO/21/09. A copy of the proposed Order and the accompanying plans showing the roads over which the means of exercise of the public right of passage are to be redetermined, together with a statement of the reasons for making the Order and our privacy notice can be viewed free of charge at the City of Edinburgh Council, Waverley Court Reception, between 09:30 and 15:30 from **10/10/25** to **07/11/25** or online during the same period at www.edinburgh.gov.uk/trafficorders and www.tellmescotland.gov.uk. (ii) All that part of the carriageway on the north side of Telford Rd and the east side of Telford Rd (Service Rd to properties 79 to 87), from the intersection of the north kerbline and the east kerbline of Telford Rd (Service Rd to properties 79 to 87), southwards for 8.7m and then eastwards for 5m and which has a width that varies from 0m to 1.9m. (iii) All that part of the carriageway on the north side of Telford Rd, from 10.6m west of the extended west kerbline of Groathill Ave, eastwards for 7.6m and which has a width that varies from 0m to 2.8m. (iv) All that part of the carriageway on the north side of Telford Rd, from 96m east of the extended east kerbline of Telford Rd (Service Rd to properties 79 to 87), eastwards for 6.8m and which has a width that varies from 0m to 2.9m. **(North-West Side)** (i) All that part of the carriageway on the north-west side of Telford Rd, from 134.2m north-east of the extended east kerbline of Telford Rd (Service Rd to properties 79 to 87), north-eastwards for 9m and which has a width that varies from 0m to 2.8m. (ii) All that part of the carriageway on the north-west side of Telford Rd and the south-west side of Telford Dr, from 10m north-west of the extended north-west kerbline of Telford Rd, south-eastwards and then south-westwards to 7.6m south-west of the extended south-west kerbline of Telford Dr and which has a width that varies from 0m to 2.5m. (iii) All that part of the carriageway on the north-west side of Telford Rd and the north-east side of Telford Dr, from 9.6m north-west of the extended north-west kerbline of Telford Rd, south-eastwards and then north-eastwards to 7.5m north-east of the extended north-east kerbline of Telford Dr and which has a width that varies from 0m to 2.1m. (iv) All that part of the carriageway on the north-west side of Telford Rd, from 25.8m north-east of the extended south-west kerbline of Telford Dr, north-eastwards for 50.6m and which has a width that varies from 0m to 2.7m. **(South Side)** (i) All that part of the carriageway on the south side of Telford Rd and the west side of Groathill Ave, from 22.3m west of the extended west kerbline of Groathill Ave, eastwards and then southwards to 13.8m south of the extended south kerbline of Telford Rd and which has a width that varies from 0m to 2.9m. (ii) All that part of the carriageway on the south side of Telford Rd and the east side of Groathill Ave, from the intersection of the extended south kerbline of Telford Rd and the extended east kerbline of Groathill Ave, southwards for 16.2m and which has a width that varies from 0m to 2.3m. **(South-East Side)** (i) All that part of the carriageway on the south-east side of Telford Rd, from 75.3m north-east of the extended east kerbline

of Groathill Ave, south-westwards for 4.8m and then southwards for 5.2m and which has a width that varies from 0m to 1.5m. (ii) All that part of the carriageway on the south-east side of Telford Rd and the south-west side of Telford Rd (access Rd for property 100), from 6.5m south-east of the extended south-west kerbline of Telford Rd (access Rd for property 100), north-eastwards and then south-eastwards to 4m south-east of the extended south-east kerbline of Telford Rd and which has a width that varies from 0m to 2.2m. (iii) All that part of the carriageway on the south-east side of Telford Rd and the north-east side of Telford Rd (access Rd for property 100), from 37.8m north-east of the extended north-east kerbline of Telford Rd (access Rd for property 100), south-westwards and then south-eastwards to 5.7m south-east of the extended south-east kerbline of Telford Rd and which has a width that varies from 0m to 3.1m. (iv) All that part of the carriageway on the south-east side of Telford Rd and the south-west side of Telford Rd (Hospital Access Rd), from 9.2m south-west of the extended south-west kerbline of Telford Rd (Hospital Access Rd), north-eastwards and then south-eastwards to 10.7m south-east of the extended south-east kerbline of Telford Rd and which has a width that varies from 0m to 2m. (v) All that part of the carriageway on the south-east side of Telford Rd and the north-east side of Telford Rd (Hospital Access Rd), from 9.2m north-east of the extended north-east kerbline of Telford Rd (Hospital Access Rd), south-westwards and then south-eastwards to 9.7m south-east of the extended south-east kerbline of Telford Rd and which has a width that varies from 0m to 1.8m.
