THE CITY OF EDINBURGH COUNCIL (SALISBURY ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION ORDER) 2025 - TEMP/25/131

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

1. This Order may be cited as “The City of Edinburgh Council (Salisbury Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025”. The Order shall have effect on the Thirty-first day of October Two thousand and twenty-five and shall remain in force up to and including the Second day of November Two thousand and twenty-five.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“bus lane” has the same meaning as in Section 44(4) of the Transport (Scotland) Act 2001;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate remedial works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of **Salisbury Road**, from the extended south-west kerbline of Dalkeith Road, south-westwards for 36 metres or thereby, daily from 19:30 hours to 06:30 hours between 31/10/2025 and 02/11/2025 respectively; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of (i) **Dalkeith Road, south-west side**, from a point 19 metres north west of the extended north-west kerbline of Salisbury Road south-eastwards for 72 metres or thereby; and (ii) **Salisbury Road, both sides**, from the extended south-west kerbline of Dalkeith Road, south-westwards for 36 metres or thereby.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.
6. The City of Edinburgh Council (A7, Dalkeith Road and Old Dalkeith Road, Edinburgh) (Bus Priority Measures) Traffic Regulation Order 2003’ will be suspended in relation to the bus lane on the south-west side of Dalkeith Road in so far as it is affected by the restrictions specified in Article 3 of this Order.

7. The alternative route for through vehicular traffic in relation to the **road closure** of **Salisbury Road** will be by way of Salisbury Road, Newington Road, East Preston Street, and Dalkeith Road.
