## THE CITY OF EDINBURGH COUNCIL (GRANGE ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION ORDER) 2025 - TEMP/25/132

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

- 1. This Order may be cited as "The City of Edinburgh Council (Grange Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025". The Order shall have effect on the Thirty-first day of October Two thousand and twenty-five and shall remain in force up to and including the Ninth day of November Two thousand and twenty-five.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
- 3. Save as provided in Article 4, to facilitate remedial works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on any part of **Tantallon Place**, from the extended north-west kerbline of Grange Road, north-westwards for 25 metres or thereby;
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of **Grange Road**, *both sides*, from extended west boundary line between numbers 39 and 41 Grange Road, westwards for 78 metres or thereby; and
  - (c) walk or cause or permit any person to walk on any part of the footpath on **Tantallon Place**, at its junction with Grange Road.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
- 5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3 of this Order.
- 6. The alternative route for through vehicular traffic in relation to the *road closure and pedestrian traffic* of **Tantallon Place** will be by way of Grange Road, Lauder Road, Hatton Place and Tantallon Place.
