THE CITY OF EDINBURGH COUNCIL (PIRNIEFIELD BANK AND SEAFIELD AVENUE)
(TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 –
TEMP/25/146

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Pirniefeld Bank and Seafeld Avenue) (Temporary Road Restriction and Traffic Regulation) Order 2025” and shall have effect on the tenth day of November Two thousand and twenty-five and shall remain in force up to and including the second day of February Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
3. Save as provided in Article 4 of this Order, to facilitate carriageway resurfacing works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit any vehicle to be driven on any part of: (i) **Pirniefeld Bank** from its junction with Pirniefeld Place, south eastwards, south westwards and south eastwards to the extended north-west building line of No. 29 Pirniefeld Bank which includes the cul-de-sac to No.’s 16-22 but excludes the access road leading to No.17 Pirniefeld Bank; and (ii) **Seafeld Avenue** at its junction with Pirniefeld Bank; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of **Pirniefeld Bank** from its junction with Pirniefeld Place south eastwards, south westwards and south eastwards to the extended north-west building line of No. 29 Pirniefeld Bank which includes the cul-de-sac to No.’s 16-22 but excludes the access road leading to No.17 Pirniefeld Bank.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. There are no available diversions with respect to the road closures of (i) **Pirniefeld Bank** and (ii) **Seafeld Avenue**, where local access will be maintained.
