

ROADS (SCOTLAND) ACT 1984

THE CITY OF EDINBURGH COUNCIL (HERRING ROAD, WATERFRONT PARK AND WEST COLONSAY VIEW, EDINBURGH) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 202__ - **RSO/25/25**

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

1. This Order may be cited as “The City of Edinburgh Council (Herring Road, Waterfront Park and West Colonsay View, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 202__” and shall come into operation on the __ day of __ Two thousand and twenty-__.
2. The road in the City of Edinburgh local government area specified in the Schedule to this Order, at present footway, shall become carriageway, the right of passage being exercisable by all classes of traffic.

SCHEDULE

**ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO
BE REDETERMINED FROM FOOTWAY TO CARRIAGEWAY**

**Waterfront Park
(north and south sides)**

1. All that part of the footway on the north and south sides of Waterfront Park from a point 65.53 metres or thereby west of the intersection of the extended west kerblines of Colonsay Close and the extended south kerblines of Waterfront Park, north-westwards for a distance of 11.5 metres or thereby and which has a width that varies from 0.86 metres or thereby to 2.89 metres or thereby.
(marked as area A1 on the attached plan)

**Herring Road
(west side)**

1. All that part of the footway on the west side of Herring Road from a point 16.49 metres or thereby north of the intersection of the extended north kerblines of Waterfront Park and the extended west kerblines of Herring Road, northwards for a distance of 35.2 metres or thereby and which has a width that varies from 0.3 metres or thereby to 0.5 metres or thereby.
(marked as area A2 on the attached plan)
2. All that part of the footway on the west side of Herring Road and the south side of West Colonsay View from a point 9.3 metres or thereby south of the intersection of the extended south kerblines of West Colonsay View and the extended west kerblines of Herring Road, northwards for a distance of 9.9 metres or thereby, then westwards for a distance of 8.3 metres or thereby and then southwards for a distance of 5.6 metres or thereby and which has a width that varies from 1.6 metres or thereby to 0.5 metres or thereby.

**West Colonsay View
(south side)**

1. See Herring Road (west side) item 2.

All as the lengths of road are shown in sawtooth hatching on the plan annexed and executed as relative to the Order.
