

THE CITY OF EDINBURGH COUNCIL (TRAFFIC REGULATION: RESTRICTIONS ON WAITING, LOADING AND UNLOADING, STOPPING AND PARKING PLACES) (VARIATION NO. _) ORDER 202_- **TRO/25/21**

The Council proposes to make an Order under the Road Traffic Regulation Act 1984 as amended to introduce permit eligibility for residents of **Ocean Dr (27, 29, 31, 33, 35, 37 & 39)**, within Controlled Parking Zone N8 (Mon-Fri between 08:30-17:30). Residents will be entitled to purchase two residential permits per household. The cost of a resident parking permit will be as follows. Vehicles registered prior to March 2001 will have charges applied in relation to engine size. Vehicles registered after March 2001 will have charges applied in relation to CO2 emissions.
