Joining an ECPC Teams Meeting or Webinar in the new year

City of Edinburgh Council are making some changes to strengthen security around Microsoft Teams, which will affect all ECPC Teams meetings, Committee, Sub-Committee and Webinars or Training. This means that any external partners will need to carry out a quick check before they join a meeting or webinar. Individuals will verify their identity using the CAPTCHA challenge or email. This is a quick test to make sure the participant is human and not an automated bot. A page will appear, like the one pictured below, and the person will be asked to enter the text on the prompt. This is being tested at the moment and will be rolled out in the new year.

Risks Outside the Home Guidance

Further, the ECPC signed off on our <u>Contextual Safeguarding- Risks Outside the Home (ROTH)</u> <u>Guidance</u> at the Committee in October 2025. The Guidance and a <u>Briefing Document</u> can be downloaded from the <u>Child Protection for Professionals</u> webpages or the <u>ECPC Knowledge Hub</u>, an easily accessible membership group.

Please note, this Guidance has superseded the Edinburgh Inter-Agency Child Sexual Exploitation (2015) that was previously developed by the Edinburgh, the Lothians and Barnardo's. This has been taken down, as it is no longer up to date.

There are also a range of other Briefings, developed by <u>The Children's Society #LookCloser</u> <u>Campaign</u>, on the ECPC Knowledge Hub. These relate primarily to different types of Exploitation for young people.

Missing Children and Young People

We are delighted to welcome <u>Missing People</u> for a good practice workshop in working with children and young people. This will take place on 21st January 2026 10.00 at Spartans Community Trust.
