THE CITY OF EDINBURGH COUNCIL (SAUGHTON CRESCENT AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/138

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Saughton Crescent Area) (Temporary Road Restriction and Traffic Regulation) Order 2025" and shall have effect on the fifth day of January Two thousand and twenty-six and shall remain in force up to and including the tenth day of April Two thousand and twenty-six, during the days and hours specified in Article 3 of this Order.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
  - "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
  - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act;
  - "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
  - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
- 3. Save as provided in Article 4 and 5 of this Order, to facilitate carriageway resurfacing, footway and drainage works (as signed as affected by the works), no person shall, between 07:00 hours and 19:00 hours, Monday to Friday:-
  - (a) drive or cause or permit any vehicle to be driven on any part of; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on any part of:
  - **Phase 1** (i) **Saughton Crescent** from the extended south-west kerbline of Murrayfield Medical Centre access road, north-eastwards to the extended west kerbline of Saughton Grove; (ii) **Beechmount Park** from the extended north-west kerbline of Saughton Crescent, north-westwards for a distance of 30 metres or thereby; (iii) **Saughton Loan** from the extended south-east kerbline of Saughton Crescent, south-eastwards for a distance of 50 metres or thereby; **Phase 2** (iv) **Saughton Crescent** from the extended west kerbline of Saughton Grove, north-eastwards to the extended north-east kerbline of Beechmount Crescent; (v) **Saughton Grove** from the extended south-east kerbline of Saughton Crescent, southwards for a distance of 50 metres or thereby; (vi) **Beechmount Crescent** from the extended north-west kerbline of Saughton Crescent, north-westwards for a distance of 30 metres or thereby; **Phase 3** (vii) **Saughton Crescent** from the extended north-east kerbline of Beechmount Crescent, eastwards to the extended north-west kerbline of Saughtonhall Drive; and (viii) **Saughton Gardens** from the extended south kerbline of Saughton Crescent, southwards for a distance of 50 metres or thereby;
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.

- 5. Nothing in Article:
  - (a) 3(a) Phase 1 shall be enacted at the same time as Article 3(a) Phases 2 and 3;
  - (b) 3(a) Phase 2 shall be enacted at the same time as Article 3(a) Phases 1 and 3; and
  - (c) 3(a) Phase 3 shall be enacted at the same time as Article 3(a) Phases 1 and 2;
- 6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 7. There are no available diversions with respect to the *road closures* of *Phase 1* (ii) **Beechmount Park**; and *Phase 2* (vi) **Beecmount Crescent**, local access will not be maintained, where practical, during the hours of operation.
- 8. The alternative route for through vehicular traffic in relation to the *road closures* will be by way of:

**Phase 1** (i) **Saughton Crescent** – Saughton Crescent, Balgreen Road, Glendevon Avenue and Saughton Grove and (iii) **Saughton Loan** – Saughton Crescent, Balgreen Road, Glendevon Avenue, Saughton Grove and Saughton Loan;

**Phase 2** (iv) **Saughton Crescent** – Saughton Crescent, Balgreen Road, Saughtonhall Avenue West, Saughtonhall Drive and Saughton Crescent, (v) **Saughton Grove** – Saughton Crescent, Balgreen Road, Glendevon Avenue and Saughton Grove;

**Phase 3** (vii) **Saughton Crescent** – Saughton Crescent, Balgreen Road and Saughtonhall Drive; and (viii) **Saughton Gardens** – Saughton Crescent, Balgreen Road, Saughtonhall Avenue West, Saughton Park and Saughton Gardens.
