THE CITY OF EDINBURGH COUNCIL (GOGAR STATION ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2025 – TEMP/25/154

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

- 1. This Order may be cited as "The City of Edinburgh Council (Gogar Station Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2025" and shall have effect on the fifth day of January Two thousand and twenty-six and shall remain in force up to and including the second day of February Two thousand and twenty-seven.
- 2. In this Order the following phrases have the meanings respectively assigned to them: "Article" means an Article of this Order;
 - "Chief Constable" means the Chief Constable of the Police Authority for Police Scotland; "emergency service vehicle" means a vehicle being used for ambulance, fire and rescue or police purposes;
 - "Parking Attendant" has the same meaning as in Section 63A of the 1984 Act; "the 2025 Order" means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic
 - "vehicle" has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
- 3. Save as provided in Article 4 and 5 of this Order, to facilitate a safe working area for a new road layout (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit any vehicle to be driven on any part of; and

- (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on any part of **both sides** of:
- Phase 1 (i) Glasgow Road (A8) eastbound off slip leading to Gogar Station Road, in its entirety; (ii) Glasgow Road (A8) westbound off slip leading to Gogar Station Road, in its entirety; (iii) Glasgow Road (A8) eastbound on slip from Gogar Station Road, in its entirety; (iv) Gogar Station Road, at a point 103 metres or thereby south of the extended south kerbline of Glasgow Road (A8);
- Phase 2 (v) Glasgow Road (A8) eastbound off slip leading to Gogar Station Road, in its entirety; (vi) Glasgow Road (A8) westbound off slip leading to Gogar Station Road, in its entirety; (vii) Glasgow Road (A8) eastbound on slip from Gogar Station Road, in its entirety; (viii) Gogar Station Road, at the extended north kerbline of the access road to the Royal Bank of Scotland Business School;
- **Phase 3** (ix) **Gogar Station Road** from the extended south kerbline of the access road to the Royal Bank of Scotland Business School, southwards to the extended north kerbline of the access road to the Royal Bank of Scotland servicing ramp; and
- **Phase 4** (x) **Gogar Station Road** from the extended south kerbline of the access road to the Royal Bank of Scotland servicing ramp, southwards to the extended north kerbline of the access to Lesser Millburn.
- 4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.

- 5. Nothing in Article:
 - (a) 3(a) Phase 1 shall be enacted at the same time as Article 3(a) Phases 2, 3, and 4;
 - (b) 3(a) Phase 2 shall be enacted at the same time as Article 3(a) Phases 1, 3, and 4;
 - (c) 3(a) Phase 3 shall be enacted at the same time as Article 3(a) Phases 1, 2 and 4;
 - (d) 3(a) Phase 4 shall be enacted at the same time as Article 3(a) Phases 1, 2 and 3.
- 6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
- 7. The alternative route for through vehicular traffic in relation to the *road closures* will be by way of: Gogar Station Road, Gogarbank, Gogarmuir Road, Roddinglaw Road, Gogarstone Road and Glasgow Road (A8).
