

The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading, Unloading and Prohibition of Motor Vehicles: North Area) Traffic Regulation Order 2026 - TRO/21/27C

The Council on 07/01/26 made the above Order, which will come into operation on 15/01/26. The effect is as stated in The Scotsman dated 05/07/24 (TRO/21/27B) & 16/08/24 (TRO/21/27B Modification), with the following changes approved by Committee & not fully implemented during the experiment: (1) Remove a waiting restriction that operates at any time & a loading prohibition that operates Mon-Fri 8.00-9.15am & 4.30-6.00pm, reverting to a waiting restriction that operates Mon-Sat 8.00am-6.30pm & Sun 12.30-6.30pm & a loading prohibition that operates Mon-Fri 8.00-9.15am & 4.30-6.30pm on Broughton St; (2) Remove a waiting restriction that operates at any time & a loading prohibition that operates Mon-Fri 8.00-9.15am & 4.30-6.00pm, reverting to a waiting restriction & pay & display bay that both operate Mon-Sat 8.00am-6.30pm & Sun 12.30-6.30pm on Forth St; (3) Remove waiting restrictions that operate at any time & loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.00pm, reverting to waiting restrictions & loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.30pm & pay & display bays that operate Mon-Fri 9.15am-4.30pm & Sat 8.00am-6.30pm on Broughton St; (4) Remove waiting restrictions that operate at any time & loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.00pm, reverting to waiting restrictions & loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.30pm & loading bays that operate Mon-Fri 9.15am-4.30pm & Sat 8.00am-6.30pm on Broughton St & Rodney St; (5) Remove a loading prohibition that operates at any time, reverting to a loading prohibition that operates Mon-Fri 8.00-9.15am & 4.30-6.30pm and a loading bay that operates Mon-Fri 9.15am-4.30pm & Sat 8.00am-6.30pm on Broughton St; (6) Remove waiting restrictions that operate at any time and loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.00pm, reverting to waiting restrictions that operate Mon-Sat 8.00am-6.30pm & loading prohibitions that operate Mon-Fri 8.00-9.15am & 4.30-6.30pm on Bellevue, Canonmills & Rodney St; (7) Remove a waiting restriction that operates at any time, reverting to a pay & display bay that operates Mon-Fri 8.30am-5.30pm on Herit Hill Ter; (8) Remove a loading prohibition that operates Mon-Fri 8.00-9.15am & 4.30-6.00pm, from an at any time waiting restriction on Heriot Hill Ter; & (9) Remove a waiting restriction that operates at any time, reverting to a waiting restriction & shared use bay that both operate Mon-Fri 8.00-5.30pm on Craigeleith Rd. Any person wishing to question the validity of the Order or any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, as amended, or on the grounds that any requirement of that Act or any relevant regulation has not been complied with in relation to the Order, may within six weeks from 07/01/26, apply to the Court of Session for this purpose.
