THE CITY OF EDINBURGH COUNCIL (KINGSNOWE ROAD NORTH AND REDHALL GROVE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 – TEMP/26/20

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Kingsknowe Road North and Redhall Grove) (Temporary Road Restriction and Traffic Regulation) Order 2026” and shall have effect on the second day of February Two thousand and twenty-six and shall remain in force up to and including the twentieth day of February Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984;
3. Save as provided in Article 4 of this Order, to facilitate road safety improvements (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit any vehicle to be driven on any part of **Kingsknowe Road North**, from the extended south-west kerbline of Redhall Road, south-westwards to the extended north-east kerbline of Longstone Place; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on **both sides** of: (i) **Kingsknowe Road North**, from the extended south-west kerbline of Redhall Road, south-westwards for a distance of 36.6 metres or thereby; and (ii) **Redhall Grove**, from the extended east building line of No. 20 Redhall Grove, westwards and then northwards to a point 2 metres or thereby north of the extended southern boundary line for property No. 28 Redhall Grove.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The alternative route for through vehicular traffic with respect to the **road closure** of **Kingsknowe Road North** will be by way of Kingsknowe Road North, Longstone Road, Inglis Green Road, Lanark Road, Kingsknowe Road South and Kingsknowe Road North.
