

ROADS (SCOTLAND) ACT 1984

THE CITY OF EDINBURGH COUNCIL (TELFORD ROAD AREA, EDINBURGH)
(REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER
2026 - RSO/21/09

The City of Edinburgh Council, in exercise of the powers conferred on them by section 1(1) and 152 (2) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

1. This Order may be cited as "The City of Edinburgh Council (Telford Road Area, Edinburgh) (Redetermination of Means of Exercise of Public Right of Passage) Order 2026" and shall come into operation on the second day of February Two thousand and twenty-six.
2. The roads in the City of Edinburgh local government area specified in the Schedule of this Order, at present carriageway, shall become footway, the right of passage being exercisable by foot only.

Telford Road
(North Side)

- (i) All that part of the carriageway on the north side of Telford Road and the west side of Telford Road (Service Road to properties 79 to 87), from a point 2.1 metres or thereby south of the extended south kerbline of Telford Road (Service Road for properties 79 to 87), southwards for a distance of 4.2 metres or thereby and then westwards for a distance of 41.9 metres or thereby and which has a width that varies from 0 metres or thereby to 3 metres or thereby.
(marked A on the attached plans)
- (ii) All that part of the carriageway on the north side of Telford Road and the east side of Telford Road (Service Road to properties 79 to 87), from the intersection of the north kerbline and the east kerbline of Telford Road (Service Road for properties 79 to 87), southwards for a distance of 8.7 metres or thereby and then eastwards for a distance of 5 metres or thereby and which has a width that varies from 0 metres or thereby to 1.9 metres or thereby.
(marked B on the attached plans)

- (iii) All that part of the carriageway on the north side of Telford Road, from a point 10.6 metres or thereby west of the extended west kerbline of Groathill Avenue, eastwards for a distance of 7.6 metres or thereby and which has a width that varies from 0 metres or thereby to 2.8 metres or thereby.
(marked E on the attached plans)
- (iv) All that part of the carriageway on the north side of Telford Road, from a point 96 metres or thereby east of the extended east kerbline of Telford Road (Service Road to properties 79 to 87), eastwards for a distance of 6.8 metres or thereby and which has a width that varies from 0 metres or thereby to 2.9 metres or thereby.
(marked F on the attached plans)

(North-West Side)

- (i) All that part of the carriageway on the north-west side of Telford Road, from a point 134.2 metres or thereby north-east of the extended east kerbline of Telford Road (Service Road to properties 79 to 87), north-eastwards for a distance of 9 metres or thereby and which has a width that varies from 0 metres or thereby to 2.8 metres or thereby.
(marked G on the attached plans)
- (ii) All that part of the carriageway on the north-west side of Telford Road and the south-west side of Telford Drive, from a point 10 metres or thereby north-west of the extended north-west kerbline of Telford Road, south-eastwards and then south-westwards to a point 7.6 metres or thereby south-west of the extended south-west kerbline of Telford Drive and which has a width that varies from 0 metres or thereby to 2.5 metres or thereby.
(marked K on the attached plans)
- (iii) All that part of the carriageway on the north-west side of Telford Road and the north-east side of Telford Drive, from a point 9.6 metres or thereby north-west of the extended north-west kerbline of Telford Road, south-eastwards and then north-eastwards to a point 7.5 metres or thereby north-east of the extended north-east kerbline of Telford Drive and which has a width that varies from 0 metres or thereby to 2.1 metres or thereby.
(marked L on the attached plans)
- (iv) All that part of the carriageway on the north-west side of Telford Road, from a point 25.8 metres or thereby north-east of the extended south-west kerbline of Telford Drive, north-eastwards for a distance of 50.6 metres or thereby and which has a width that varies from 0 metres or thereby to 2.7 metres or thereby.
(marked M on the attached plans)

(South Side)

- (i) All that part of the carriageway on the south side of Telford Road and the west side of Groathill Avenue, from a point 22.3 metres or thereby west of the extended west kerbline of Groathill Avenue, eastwards and then southwards to a point 13.8 metres or thereby south of the extended south kerbline of Telford Road and which has a width that varies from 0 metres or thereby to 2.9 metres or thereby.
(marked C on the attached plans)

- (ii) All that part of the carriageway on the south side of Telford Road and the east side of Groathill Avenue, from the intersection of the extended south kerbline of Telford Road and the extended east kerbline of Groathill Avenue, southwards for a distance of 16.2 metres or thereby and which has a width that varies from 0 metres or thereby to 2.3 metres or thereby.
(marked D on the attached plans)

(South-East Side)

- (i) All that part of the carriageway on the south-east side of Telford Road, from a point 75.3 metres or thereby north-east of the extended east kerbline of Groathill Avenue, south-westwards for a distance of 4.8 metres or thereby and then southwards for a distance of 5.2 metres or thereby and which has a width that varies from 0 metres or thereby to 1.5 metres or thereby.
(marked H on the attached plans)
- (ii) All that part of the carriageway on the south-east side of Telford Road and the south-west side of Telford Road (access road for property 100), from a point 6.5 metres or thereby south-east of the extended south-west kerbline of Telford Road (access road for property 100), north-eastwards and then south-eastwards to a point 4 metres or thereby south-east of the extended south-east kerbline of Telford Road and which has a width that varies from 0 metres or thereby to 2.2 metres or thereby.
(marked I on the attached plans)
- (iii) All that part of the carriageway on the south-east side of Telford Road and the north-east side of Telford Road (access road for property 100), from a point 37.8 metres or thereby north-east of the extended north-east kerbline of Telford Road (access road for property 100), south-westwards and then south-eastwards to a point 5.7 metres or thereby south-east of the extended south-east kerbline of Telford Road and which has a width that varies from 0 metres or thereby to 3.1 metres or thereby.
(marked J on the attached plans)
- (iv) All that part of the carriageway on the south-east side of Telford Road and the south-west side of Telford Road (Hospital Access Road), from a point 9.2 metres or thereby south-west of the extended south-west kerbline of Telford Road (Hospital Access Road), north-eastwards and then south-eastwards to a point 10.7 metres or thereby south-east of the extended south-east kerbline of Telford Road and which has a width that varies from 0 metres or thereby to 2 metres or thereby.
(marked N on the attached plans)
- (v) All that part of the carriageway on the south-east side of Telford Road and the north-east side of Telford Road (Hospital Access Road), from a point 9.2 metres or thereby north-east of the extended north-east kerbline of Telford Road (Hospital Access Road), south-westwards and then south-eastwards to a point 9.7 metres or thereby south-east of the extended south-east kerbline of Telford Road and which has a width that varies from 0 metres or thereby to 1.8 metres or thereby.
