THE CITY OF EDINBURGH COUNCIL (CORSTORPHINE HILL AVENUE AND CORSTORPHINE HILL GARDENS AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 – TEMP/26/12


THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Corstorphine Hill Avenue and Corstorphine Hill Gardens Area) (Temporary Road Restriction and Traffic Regulation) Order 2026”. The Order shall have effect on the Twenty-third day of February Two thousand and twenty-six and shall remain in force up to and including the Fifteenth day of May Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway resurfacing and footway works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on any part of: (i) **Corstorphine Hill Avenue**, in its entirety; and (ii) **Corstorphine Hill Gardens**, in its entirety; and
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of: (i) **Corstorphine Hill Avenue, both sides**, in its entirety; (ii) **Corstorphine Hill Gardens, both sides**, in its entirety; (iii) **Corstorphine Hill Road, both sides**, from a point 40 metres or thereby north of the extended north kerbline of Corstorphine Hill Avenue, southwards to a point 40 metres or thereby south of the extended south kerbline of Corstorphine Hill Gardens; and (iv) **Kaimes Road, both sides**, from a point 40 metres or thereby north of the extended north kerbline of Corstorphine Hill Avenue, southwards to a point 40 metres or thereby south of the extended south kerbline of Corstorphine Hill Gardens.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The alternative route for through vehicular traffic in relation to the **road closures** will be by way of Kaimes Road, Corstorphine Hill Crescent and Corstorphine Hill Road.
