THE CITY OF EDINBURGH COUNCIL (RESTALRIG ROAD AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 - TEMP/26/25

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order:-

1. This Order may be cited as “The City of Edinburgh Council (Restalrig Road Area) (Temporary Road Restriction and Traffic Regulation) Order 2026”. The Order shall have effect on the Second day of March Two thousand and twenty-six and shall remain in force up to and including the Third day of July Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;  
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate carriageway resurfacing, footway and drainage works (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on the sections of roads specified in Schedule 1 hereto, where closures will apply to roads in their entirety unless otherwise stated;
  - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle on the sections of the roads specified in Schedule 2 hereto, where prohibitions will apply to both sides of the roads in their entirety unless otherwise stated;
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.
6. The alternative route for through vehicular traffic in relation to the *road closures* will be by way of: (i) **Restalrig Road & (ii) Restalrig Road South:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Lochend Road South, Sleigh Drive; (iii) **East Restalrig Terrace:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Restalrig Terrace, East Restalrig Terrace; (iv) **Blackie Road:** Gladstone Place, Claremont Park, Claremont Road, Blackie Road; (v) **Cornhill Terrace:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Restalrig Terrace, Cornhill Terrace; (vi) **Ryehill Terrace:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Restalrig Terrace, Cornhill Terrace, Ryehill Terrace; (vii) **Prospect Bank Road:** Gladstone Place, Claremont Park, Claremont Road, Prospect Bank Road; (xi) **Restalrig Circus:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Lochend Road South, Sleigh Drive, Findlay Avenue, Restalrig Circus; (xiii) **Lochend Avenue:** East Hermitage Place, Hermitage Place, Vanburgh Place, Lochend Road, Lochend Road South, Sleigh Drive, Lochend Avenue; & (xiv) **Restalrig Crescent:** East Hermitage Place, Hermitage Place,

Vanburgh Place, Lochend Road, Lochend Road South, Sleigh Drive, Findlay Avenue,  
Restalrig Crescent.

7. There is no available diversion with respect to the **road closures** of: (viii) **Easter Hermitage**; (ix) **Prospect Bank Gardens**; (x) **Ale Moor Park**; (xii) **Restalrig Park**; (xv) **Restalrig Square**; & (xvi) **Restalrig Road South (No.178 access road)**, where local access will be maintained.

(i) **Restalrig Road**; (ii) **Restalrig Road South**, from the extended south-east kerbline of Restalrig Crescent, southwards to the extended north-east kerbline of Sleigh Drive; (iii) **East Restalrig Terrace**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (iv) **Blackie Road**, from the extended north-east kerbline of Restalrig Road, eastwards for a distance of 30 metres or thereby; (v) **Cornhill Terrace**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (vi) **Ryehill Terrace**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (vii) **Prospect Bank Road**, from the extended north-east kerbline of Restalrig Road, eastwards for a distance of 30 metres or thereby; (viii) **Easter Hermitage**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (ix) **Prospect Bank Gardens**, from the extended north-east kerbline of Restalrig Road, eastwards for a distance of 30 metres or thereby; (x) **Ale Moor Park**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (xi) **Restalrig Circus**, from the extended north-east kerbline of Restalrig Road, eastwards for a distance of 30 metres or thereby; (xii) **Restalrig Park**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 30 metres or thereby; (xiii) **Lochend Avenue**, from the extended north-west kerbline of Restalrig Road, westwards for a distance of 50 metres or thereby; (xiv) **Restalrig Crescent**, from the extended north-east kerbline of Restalrig Road South, eastwards for a distance of 30 metres or thereby; (xv) **Restalrig Square**, from the extended north-east kerbline of Restalrig Road South, eastwards for a distance of 50 metres or thereby; (xvi) **Restalrig Road South (No.178 access road)**, from the extended north-east kerbline of Restalrig Road South, eastwards for a distance of 30 metres or thereby;

## SCHEDULE 2

### PROHIBITION OF WAITING, LOADING & UNLOADING
