THE CITY OF EDINBURGH COUNCIL (BANKHEAD DRIVE AND BANKHEAD AVENUE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 – TEMP/26/87

THE CITY OF EDINBURGH COUNCIL in exercise of the powers confer on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Bankhead Drive and Bankhead Avenue Area) (Temporary Road Restriction and Traffic Regulation) Order 2026”. The Order shall have effect on the Fifteenth day of May Two thousand and twenty-six and shall remain in force up to and including the Thirtieth day of July Two thousand and twenty-six, during the hours and dates specified in the Schedules of this Order.
2. In this Order the following phrases have the meanings respectively assigned to them:  
“Article” means an Article of this Order;  
“Chief Constable” means the Chief Constable of the Police Authority for Police Scotland;  
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;  
“road” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984 and, for the avoidance of doubt, for the purposes of this Order, includes part of a road;  
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and  
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate road and footway improvements for the West Edinburgh Link project, (as signed as affected by the works), no person shall:-
  - (a) drive or cause or permit to be driven any vehicle on any part of the road specified in Schedule 1;
  - (b) except upon the direction or with the permission of a police constable in uniform, drive or cause or permit any vehicle to be driven on the lengths of roads specified in column 1 of Schedule 2, otherwise than in the direction specified in column 2 of the said Schedule, provided that no more than one of the measures described in Schedule 2 shall be enacted at the same time;
  - (c) except with the permission of a Parking Attendant, cause or permit any vehicle to wait, or load onto or unload from any vehicle on any part of the road specified in Schedule 3.
  - (d) walk or cause or permit any person to walk on any part of the footways specified in Schedule 4.
4. Nothing in:
  - (a) Article 3(a), (b) and (c) of this Order shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
  - (b) Article 3(d) of this Order shall prevent any person from walking or causing or permitting any person to walk on the part of the road specified in this Order if the person is there in connection with the works.
5. The City of Edinburgh Council (West Edinburgh Bus Priority Lanes) Traffic Regulation Order 2004 will be suspended on **Bankhead Drive** in so far as the westbound bus lane is affected by the restrictions specified in Article 3(a) of this Order to allow westbound traffic and to accommodate traffic management lane closures for the duration of this Order.

6. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(c) of this Order.
7. The following Order “The City of Edinburgh Council (Bankhead Driver and Bankhead Avenue Area) Order 2025” is hereby revoked.
8. The alternative route for through vehicular traffic in relation to the **road closure** on **Bankhead Avenue** will be by way of Bankhead Crossway North, Bankhead Broadway and Bankhead Drive.
9. The alternative route for through vehicular traffic in relation to the **one-way roads** on:
  - (a) **Bankhead Drive** will be by way of; (i) Bankhead Drive, Broomhouse Road, Calder Road and Bankhead Avenue; (ii) Bankhead Broadway, Bankhead Crossway North, Bankhead Avenue, Calder Road and Broomhouse Road; and
  - (b) **Bankhead Avenue** will be by way of Bankhead Crossway North, Bankhead Broadway and Bankhead Drive.
10. The alternative route for through pedestrian traffic in relation to:
  - (a) the **footway closure** of **Bankhead Drive, south side**, will be by way of Bankhead Drive, *north side*;
  - (b) the **footway closure** of **Bankhead Drive, north side**, will be by way of Bankhead Drive, *south side*;
  - (c) the **footway closure** of **South Gyle Access, east side**, will be by way of Bankhead Drive, *south side*, and South Gyle Access, *west side*.
  - (d) the **footway closure** of **Bankhead Avenue, east side**, will be by way of Bankhead Avenue, *west side*.

**SCHEDULE 1  
ROAD CLOSURE**

*From 19:00 hours to 06:00 hours each day from 15/05/2026 to 30/07/2026 on:*

**Bankhead Avenue**, from the extended south kerbline of Bankhead Drive, southwards and then westwards for a distance of 230 metres or thereby.

**SCHEDULE 2  
ONE-WAY ROADS**

*From 00:00 hours on 15/05/2026 to 23:59 hours 30/07/2026 on:*

<b>Bankhead Drive</b> , from the extended east kerbline of Bankhead Avenue, eastwards for a distance of 80 metres or thereby.	West to East
<b>Bankhead Drive</b> , from the extended east kerbline of Bankhead Broadway, eastwards to the extended west kerbline of South Gyle Access.	East to West
<b>Bankhead Avenue</b> , from the extended south kerbline of Bankhead Drive, southwards and then westwards for a distance of 230 metres or thereby.	North to South
<b>Bankhead Avenue</b> , from the extended south kerbline of Bankhead Drive, southwards for a distance of 150 metres or thereby.	South to North

**SCHEDULE 3  
PROHIBITION OF WAITING, LOADING AND UNLOADING**

*From 00:00 hours on 15/05/2026 to 23:59 hours on 30/07/2026 on:*

**Bankhead Avenue, south side**, from a point 9 metres or thereby east of the extended east kerbline of Bankhead Avenue (*leg south of Bankhead Crossway North*), eastwards to a point 8 metres or thereby west of the extended north-west kerbline of the access road to Edinburgh College.

**SCHEDULE 4  
FOOTWAY CLOSURES**

*From 00:00 hours on 15/05/2026 to 23:59 hours on 30/07/2026 on:*

- (a) **Bankhead Drive, south side**; (i) from the extended east kerbline of Bankhead Avenue, eastwards for a distance of 100 metres or thereby; (ii) from the extended west kerbline of Bankhead Avenue, westwards for a distance of 10 metres or thereby;
- (b) **Bankhead Drive, north side**, from the extended west kerbline of South Gyle Access, westwards for a distance of 100 metres or thereby;
- (c) **South Gyle Access, east side**, from the extended north kerbline of Bankhead Drive, northwards for a distance of 25 metres or thereby; and
- (d) **Bankhead Avenue, east side**, from the extended south kerbline of Bankhead Drive, southwards and then westwards for a distance of 200 metres or thereby.
