THE CITY OF EDINBURGH COUNCIL (FERNIESIDE GARDENS AND PLACE) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 – TEMP/26/109

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Fernieside Gardens and Place) (Temporary Road Restriction and Traffic Regulation) Order 2026”. The Order shall have effect on the Sixth day of July Two thousand and twenty-six and shall remain in force up to and including the Twenty-third day of August Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate sewer connection works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of: **Phase 1** (i) **Fernieside Gardens**, from the extended north-east kerbline of Fernieside Place, north-eastwards for a distance of 30 metres or thereby; and **Phase 2** (ii) **Fernieside Place**, from extended north-west kerbline of Fernieside Gardens, north-westwards for a distance of 45 metres or thereby;
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of: (i) **Fernieside Gardens**, from the extended north-east kerbline of Fernieside Place, north-eastwards for a distance of 30 metres or thereby; and (ii) **Fernieside Place**, from extended north-west kerbline of Fernieside Gardens, north-westwards for a distance of 45 metres or thereby;
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. Nothing in Article 3(a):
 - (a) **Phase 1** shall be enacted at the same time as Article 3(a) **Phase 2**
 - (b) **Phase 2** shall be enacted at the same time as Article 3(a) **Phase 1**
6. The alternative route for through vehicular traffic in relation to the **road closures** of: **Phase 1** (i) Fernieside Gardens and **Phase 2** (ii) Fernieside Place, will be by way of Fernieside Gardens, Moredun Park Road, Fernieside Place.
