THE CITY OF EDINBURGH COUNCIL (NEWBATTLE TERRACE AREA) (TEMPORARY ROAD RESTRICTION AND TRAFFIC REGULATION) ORDER 2026 – TEMP/26/119

THE CITY OF EDINBURGH COUNCIL in exercise of the powers conferred on them by Section 14 (1) (a) of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other powers enabling them in that behalf hereby make the following Order: -

1. This Order may be cited as “The City of Edinburgh Council (Newbattle Terrace Area) (Temporary Road Restriction and Traffic Regulation) Order 2026”. The Order shall have effect on the Twelfth day of August Two thousand and twenty-six and shall remain in force up to and including the Tenth day of September Two thousand and twenty-six.
2. In this Order the following phrases have the meanings respectively assigned to them:
“Article” means an Article of this Order;
“emergency service vehicle” means a vehicle being used for ambulance, fire and rescue or police purposes;
“Parking Attendant” has the same meaning as in Section 63A of the 1984 Act;
“the 2025 Order” means The City of Edinburgh Council (Traffic Regulation; Restrictions on Waiting, Loading and Unloading, Stopping and Parking Places) Designation and Traffic Regulation Order 2025; and
“vehicle” has the same meaning as in Section 151 of the Roads (Scotland) Act 1984.
3. Save as provided in Article 4, to facilitate Scottish Power trial hole works (as signed as affected by the works), no person shall:-
 - (a) drive or cause or permit to be driven any vehicle on any part of the roads specified in Schedule 1, provided that no more than one of the measures in **Phase 1**, **Phase 2** and **Phase 3**, described in Schedule 1 be enacted at the same time; and
 - (b) except with the permission of a Parking Attendant, cause or permit any vehicle to wait or load onto or unload from any vehicle at any time on any part of the roads specified in Schedule 2.
4. Nothing in Article 3 shall apply to emergency service vehicles or vehicles in actual use with the undertaking of the works.
5. The 2025 Order will be suspended in so far as it is affected by the restrictions specified in Article 3(b) of this Order.

6. The City of Edinburgh (Canaan Lane) (Temporary Road Restriction and Traffic Regulation) Order 2026, for the duration of this Order, shall have effect as if:
In Article 5 for the words ‘**(southbound)** Canaan Lane, Newbattle Terrace, Morningside Road, Cluny Avenue, Braid Avenue, Woodburn Terrace and Canaan Lane; **(northbound)** Canaan Lane, Morningside Road, Newbattle Terrace and Canaan Lane.’ there were substituted the words:-
‘**(southbound)** Canaan Lane, Newbattle Terrace, Whitehouse Loan, Strathearn Place, Greenhill Gardens, Chamberlain Road, Morningside Road, Cluny Avenue, Braid Avenue, Woodburn Terrace and Canaan Lane; **(northbound)** Canaan Lane, Morningside Road, Chamberlain Road, Greenhill Gardens, Strathearn Place, Whitehouse Loan, Newbattle Terrace and Canaan Lane.’
7. The alternative routes for through vehicular traffic in relation to the **road closures** in Schedule 1 will be by way of:
- (a) **Phase 1** (i) **Church Hill/Clinton Road** - Clinton Road, Whitehouse Loan, Newbattle Terrace, Morningside Road, Church Hill Place and Church Hill; (ii) **Pitsligo Road** - Pitsligo Road, Newbattle Terrace, Whitehouse Loan and Clinton Road;
 - (b) **Phase 2 Pitsligo Road** - (1) Clinton Road, Whitehouse Loan and Newbattle Terrace, or (2) Church Hill. Church Hill Place, Morningside Road and Newbattle Terrace;
 - (c) **Phase 3** (i) **Newbattle Terrace** - Newbattle Terrace, Morningside Road, Church Hill Place, Church Hill, Clinton Road, Whitehouse Loan, Newbattle Terrace; (ii) **Pitsligo Road** - Pitsligo Road, Clinton Road, Whitehouse Loan and Newbattle Terrace.

SCHEDULE 1 ROAD CLOSURES

Phase 1, (i) **Church Hill/Clinton Road**, from a point 5 metres or thereby east of the extended east kerbline of Pitsligo Road, north-westwards for a distance of 55 metres or thereby; and (ii) **Pitsligo Road**, at its junction with Church Hill/Clinton Road.

Phase 2, Pitsligo Road, from the extended south kerbline of Church Hill/Clinton Road, southwards to the extended north kerbline of Newbattle Terrace.

Phase 3, Newbattle Terrace, from the extended west kerbline of Pitsligo Road, eastwards to the extended west kerbline of Canaan Lane; and (ii) **Pitsligo Road**, at its junction with Newbattle Terrace.

SCHEDULE 2 PROHIBITION OF WAITING LOADING AND UNLOADING

- (a) **Church Hill, south side**, from the extended south kerbline of Church Hill, south-eastwards to the extended west kerbline of Pitsligo Road; and
- (b) **Newbattle Terrace, both sides**, from the extended east kerbline of Eden Lane, eastwards to the extended west kerbline of Canaan Lane.
