

### **Project Newsletter: 21 January 2020**



Trams are timetabled in Leith and Newhaven in Spring 2023.

Welcome to the first newsletter of 2020 and Happy New Year from the team. In this edition find out more about the upcoming plans and activities for the next two weeks.











### January 2020 works overview

On Leith Walk, works are progressing well with the creation of the city-bound running lane as part of the ongoing enabling works ahead of the main construction starting in March 2020. This is being done on a phased basis in order to minimise disruption to residents and businesses.

Ground investigation works continue to take place across the route which will help inform final designs.

Investigation works on Lindsay Road will continue including nightshift works which are scheduled to finish on Wednesday 22 January.

Preparation works to the two roundabouts at Ocean Terminal will also be taking place from Wednesday 22 January and traffic management will be in place to accommodate this.

Morrison Utility Services (MUS) will continue excavating Constitution Street to allow for any required utility diversions. As part of this, a number of trial holes will be required at different locations on the footpaths. These are being carried out to confirm locations of overhead line poles (OLE). Pedestrian diversions will be in place to maintain access for all.

### **Road Closure Brunswick Road**

Access to/from Leith Walk to Brunswick Road will be closed from Wednesday 29 January 2020 for approximately five days to allow CityFibre to install broadband for local residents/businesses.


Advanced notification signage will be in place and traffic diversions will be in operation. Pedestrian access will be maintained at all times.











## South Leith Parish Church Boundary Wall

A number of historic masonry structures and public sculptures on the wall need to be carefully taken down to allow essential groundworks to take place.

These will be stored, conserved and re-built once the tram lines are installed. The wall has been subject to detailed 3D recording techniques and each stone will be marked with a unique identification reference to provide information for the wall to be rebuilt.

As the wall and the monuments are listed by Historic Environment

Scotland, specialist members of the project team are using the same kind of tools and working practices to separate the individual stones as those the original masons would have used to build the wall. This painstaking work is revealing a fascinating insight into the workmanship and building methods of the past.

### Tell us a little about yourself...

sure you will see me out and about so feel free to say hello!


#### What part of the project are you most looking forward to?


